DISTRICT SERVICE COMMITTEES
(DELEGATION OF THE POWERS OF THE PRESIDENT UNDER ARTICLE 104) DIRECTIVE

WHEREAS under Clause (2) of the Article 103 of the Constitution, the powers to appoint the Chairman and other members of the District Service Committees is vested in the President:

AND WHEREAS Government has decided to create a process of decentralization whereby function, powers, services and responsibilities are transferred from the Central Government to Local Governments:

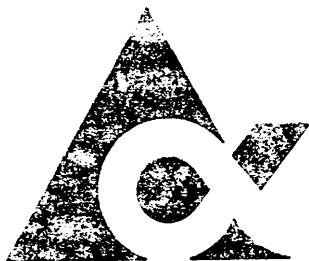
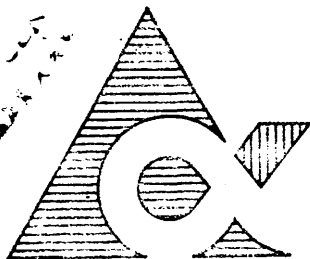

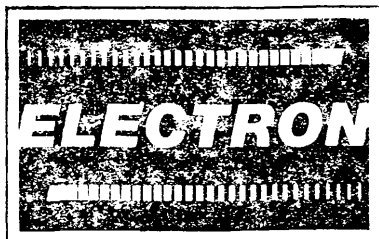
