APPOINTMENT OF POLLING DAY.

(BUKOMANSIMBI ELECTORAL AREA).

Under Third Schedule rule 14 (1).

NOTICE.

IN EXERCISE of the powers conferred upon the Commissioner for the Constituent Assembly by sub-rule (1) of the Constituent Assembly (Election) Rules, contained in the Third Schedule to the Statute, Monday, 27th June, 1994, is appointed Polling Day for Bukomansimbi Electoral Area for the purpose of the repeat of the election of a delegate to the Constituent Assembly.

While the Office of the Commissioner for the Constituent Assembly shall continue to give a general direction relating to these elections, the following shall apply in respect of the appointed polling day:

- (a) the Returning Officer and Assistant Returning Officers earlier appointed for Masaka district shall be Returning Officer and Assistant Returning Officers;
- (b) polling shall commence at all Polling Stations at 7.00 a.m. in the forenoon and close at 5.00 o'clock in the afternoon;
- (c) the candidates in the repeat elections shall be the same duly nominated for the Constituent Assembly Elections which were held on 28th March, 1994;
- (d) no Candidates' Meetings or other public meetings intended to canvass votes shall be permitted for the purposes of the repeat election;
- (e) only voters whose names appear in the register of voters shall be permitted to vote;
- (f) every voter whose names appear in the register of voters shall have his or her certificate of registration stamped before obtaining a ballot paper;
- (g) a voter whose names appear in the register of voters but who has lost his or her registration certificate, may only be permitted to vote if the RC I Chairman of the voter's village and four other RC Committee members of the voter's village certify in writing to the Presiding Officer that the voter is actually the person whose names appear in the register;
- (h) at the closure of every polling station and after the declaration of the results at the polling station, every Presiding Officer shall be required to deliver to the respective sub-county headquarters the Declaration of Results Form duly signed by the Presiding Officer and the agents of the candidates. One copy of the same Form shall be sealed in the ballot box and a third copy left displayed at the polling station.
