NOTICE OF INTENDED APPLICATION FOR A LICENSE TO GENERATE AND SALE ELECTRICITY

The Electricity Regulatory Authority (ERA) under section 29 of the Electricity Act 1999, Cap 145, received a Notice of Intended Application for a license from Electro-Maxx (U) Limited to generate and sale electricity.

Electro-Maxx (U) Ltd proposes to develop a 10 MW HFO Plant in Mbarara to generate and sale electricity to the grid.

ERA has made a preliminary assessment of the application in accordance with requirements laid out in Section 29 of the Electricity Act, 1999, Cap 145, and has requested the developer to clarify on matters regarding project financing, acquisition of physical site in Mbarara, and the impacts of the project.


