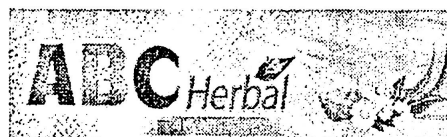

**The Finance (Permitted Plastic Bags and Other Plastics for
Exceptional Use), Regulations, 2010**

(Under section 3 (2) and (3) of the Finance Act, 2009, Act No. 14 of 2009)

IN EXERCISE of the powers conferred on the Minister responsible for finance by section 3 (2), and (3) of the Finance Act 2009 and in consultation with the Minister responsible for the environment, these Regulations are made this 2nd day of June, 2010.

1. Title

These Regulations may be cited as the Finance (Permitted Plastic Bags and Other Plastics for Exceptional Use), Regulations, 2010

2. Commencement

These Regulations shall come into force on 1st September, 2010.

3. Interpretation

In these Regulations, unless the context otherwise requires—

“authorised officer” includes a customs officer, an environmental inspector and a police officer;

“Executive Director” means the Executive Director of the National Environment Management Authority; and

“plastic bags” means carrier sacks and bags made of polymers of ethylene for the conveyance and packaging of goods.

4. Prohibition of importation, sale and use of plastic bags

A person shall not manufacture, import, sell, use, distribute or otherwise deal in plastic bags except—

- (a) plastic woven bags for the packaging and conveyance of goods; and
- (b) plastic bags and other plastics for exceptional uses specified in the Schedule.

5. Permit to manufacture, use, import and sale plastic bags

(1) Any person who intends to manufacture, import, sell, use, distribute or otherwise deal in plastic bags and other plastics for exceptional uses specified in the Schedule shall apply to the Executive Director for a permit.

(2) An application under subregulation (1) shall be in the prescribed form and shall be accompanied by the prescribed fee.

(3) The Executive Director shall, on receipt of an application under this regulation issue or refuse to issue the permit within twenty one days after receipt of the application.

6. Administrative penalty

(1) Where an authorised officer has reasonable grounds to believe that a person has committed an offence under these Regulations, the authorised officer may serve an administrative penalty notice on that person.

(2) An administrative penalty notice issued under subsection (2) shall—

- (a) specify the date and nature of the alleged offence;
- (b) contain a summary of the facts which the authorised officer alleges;
- (c) constitute an offence in sufficient detail for the accused person to reasonably be able to understand the nature of the allegation;

- (d) be endorsed with a statement setting out the provisions of this regulation;
- (e) specify the amount of the fixed penalty payable in respect of the offence which is alleged to have been committed; and
- (f) give details, including the address of the officer to whom the payment is to be made.

(3) A person on whom an administrative penalty notice has been served under this regulation may, within thirty days after receipt of the notice, admit the offence in writing, by notice addressed to the authorised officer, and immediately pay to the authorised officer, the penalty specified in the notice.

(4) A person who admits having committed an offence described in an administrative penalty notice but who fails to pay the fixed penalty within forty five days after the date of the administrative penalty notice is liable to prosecution in respect of the alleged offence.

(5) A person on whom an administrative penalty notice has been served who denies, by notice in writing to the authorised officer, that an offence has been committed or who fails to respond to the administrative penalty notice within thirty days after service of notice on him or her, is liable, in the discretion of the prosecuting authority, to prosecution in respect of the alleged offence.

(6) Where a person is found in possession of plastic bags prohibited by regulation 4, the plastic bags may be seized by the authorised officer.

(7) Where a seizure is made under subregulation (6) the plastic bags shall be forfeited to the State.

7. Offences and penalties

(1) Any person who manufactures, imports, sells, distributes or otherwise deals in plastic bags and other plastics prohibited by regulation 4 commits an offence and is liable on conviction to a fine of one hundred and twenty thousand shillings and to an additional penalty of seventy thousand shillings for each day or part of a day during which the offence has continued.

- (2) A court convicting a person under subregulation (1) shall—
- (a) order the forfeiture of any plastic bags, in respect of which the offence was committed or which were found in that person's possession; and
 - (b) order the cancellation of the permit held by that person.

Plastic bags used for the packaging of candy sweets, biscuits, pasta, sugar, juice, milk, coffee, tea, salt, rice, candles, soaps, detergents, and any other food or cosmetic product requiring moisture barrier properties

Plastic films used for shrink wrapping of water, soaps and cosmetic products

Cling film for value addition of tea and coffee

Plastic paper used for wrapping mattresses while in the warehouse

Plastic bags for packaging cereal flour

B: Agriculture Use

Plastic bags used for plants nurturing in nurseries

Plastic sheeting for agricultural, horticultural or floricultural use

Plastic bags used for packaging fertilizers into small units for export

Plastic bags used for packaging seeds for sowing

C: Medical Use

Plastic bags used for conditioning and packaging of drugs, vaccines and other medical and pharmaceutical products

Plastic bags for medical use

D: Research and Science

Plastic bags used for the conditioning of laboratory reactants and other laboratory products

E: Sanitation

Plastic bags used for the collection and transportation of wastes

F: Construction

Plastic bags used for insulation, roofing and damp proofing in construction

G: Exports

Plastic bags for packaging of exports
