**The Public Order Management Act (Commencement)  
Instrument, 2013.**

*(Under section 1 of the Public Order Management Act, 2013, Act No.9 of 2013)*

IN EXERCISE of the powers conferred upon the Minister responsible for Internal Affairs by section 1 of the Public Order Management Act, 2013, this Instrument is made this 9th day of November, 2013.

**1. Title.**

This Instrument may be cited as the Public Order Management Act (Commencement) Instrument, 2013.

**2. Appointment of commencement date for Act No. 9 of 2013.**

The 20th day of November, 2013 is appointed as the day on which the Public Order Management Act, 2013 shall come into force.
