BY-ELECTION—KYAMUSWA ELECTORAL AREA DECLARATION OF NOMINATION DAYS.

WHEREAS the delegate for Kyamuswa Electoral Area, Kalangala District the late Honourable Sam Ssemaala Kirundu Kimize Kiwanuka died on Friday, 14th October, 1994;

AND WHEREAS the Minister of State for Constitutional Affairs has, on Monday 4th Friday, November 1994, issued a Writ requiring the Commissioner for the Constituent Assembly to take appropriate steps for a by-election to take place in Kyamuswa Electoral Area in order to fill the vacancy
NOW THEREFORE:

1. In accordance with sub-rule (1) of rule 7 of the Constituent Assembly Statute, 1994, I declare Monday 7th and Tuesday 8th November, 1994, Nomination days for candidates for the by-election to take place in Kyamuswa Electoral Area, Kalangala District.

2. Every person aspiring to be a candidate for the by-election shall tender his/her nomination paper to the Returning Officer on any of those two days between the hours of 10.00 a.m. and 4.00 p.m.

3. The place where the nomination of candidates shall take place is the office of the Returning Officer, Kalangala District, who is the DES for Kalangala District.

4. Every person wishing to be nominated as a candidate,
- (a) shall submit to the Returning Officer a Nomination Paper in Form NP which may be collected from the office of the Returning Officer or from the Commission for the Constituent Assembly, Ruth Towers before nomination days; and
 - (b) shall submit to the Returning Officer a copy of Form DQ (Declaration of Qualifications) duly sworn before a Commissioner for oaths. Form DQ may also be collected from the office of the Returning Officer Kalangala, or from the Commission of the Constituent Assembly, Ruth Towers before nomination days;

5. The nomination of every candidate—

- (a) shall be proposed by two registered voters of Kyamuswa Electoral Area and who normally reside in that Electoral Area;
- (b) shall be supported by ten registered voters of Kyamuswa Electoral Area and who normally reside in that Electoral Area;
- (c) shall be accompanied by a fee of one hundred thousand shillings payable in cash or bankdraft to Uganda Administration; and
- (d) shall be accompanied by three passport size photographs of the person seeking nomination. However, the picture of each aspiring candidate copies of which the contending candidate shall submit to the Returning Officer, shall be taken by the Returning Officer immediately prior to the nomination process.

6. The Returning Officer shall design a programme of Candidates Meetings, so that one Candidates Meeting takes place in each of the eight parishes of Kyamuswa Electoral Area between Saturday 12th November, 1994 and Sunday 20th November, 1994.
