The notice must state the name and address of the person, or if a firm, and address of the firm, and must be signed by the person or firm, or his or their advocate (if any) and must be served, or if posted must be sent by post, in sufficient time to reach the above named not later than 4:00 O'clock in the afternoon of the 1st day of September, 2000.
