THE UGANDA ADVANCED CERTIFICATE OF EDUCATION AND ITS EQUIVALENT FOR PERSONS WISHING TO RUN FOR PARLIAMENTARY ELECTIONS.

PREAMBLE

BY VIRTUE of the powers conferred upon the Uganda National Examinations Board (UNEB) under section 5 (5) of the Parliamentary Elections Act, 2001, the Uganda National Examinations Board hereby publishes the following list of qualifications considered as 'A' Level or its equivalent. 1. A person shall be deemed to have an 'A' level certificate on presentation of an original 'A' level certificate issued by the Uganda National Examinations Board, the East African Examinations Council or Cambridge Local Examinations Syndicate.

2. A person who does not possess an 'A' level certificate as in (1) above shall be required to produce evidence of an equivalent qualification as in Schedules (1) and (2).

SCHEDULE 1

Equivalencies based on qualifications obtained within Uganda:

- (a) A Grade III Teachers' certificate awarded by the Institute of Teacher Education, Kyambogo to a teacher who pursues the course for two years after UCE level or Grade II Teachers' Certificate and has taken a continuous Grade III course lasting for at least two years.
- (b) A Technical Certificate or a Diploma awarded by UNEB or other recognised examining body to a person who holds a UCE Certificate and has studied for at least two continuous years in a Technical institution.
- (c) A Business Certificate awarded by UNEB or other recognised examining bodies, to a person who holds a UCE Certificate and has studied for at least two years continuously in a Business institution.
- (d) A certificate awarded by a recognised military, police or prisons college or academy or school to a person who has after 'O' level and the basic military, police or prisons course completed an approved course of not less than six months at the college, academy or school

SCHEDULE 2

Equivalencies based on qualifications obtained elsewhere:

Candidates presenting equivalent qualifications obtained outside Uganda shall be required to submit certified copies from the Regulatory Agency responsible for education in the countries in which certificates are obtained, along with their course content. Section 12. NOTICE.


2. (1) The persons listed in column 1 of the Schedule are granted exclusive licences to import used tyres of different sizes, in the quantities listed in column 2 of the Schedule.

6. The Council or its agents shall be responsible for the control and management of parking places.

The National Youth Council (Amendment of Schedule) Instrument, 2001.

IN EXERCISE of the powers conferred on the Minister by subsection (2) of section 29 of the National Youth Council Statute 1993, this Instrument is made this 2nd day of May, 2001.

1. This Instrument may be cited as the National Youth Citation. Council (Amendment of Schedule) Instrument, 2001 and shall be deemed to have come into force on the 1st day of November, 2000.
