## The Traffic and Road Safety (Speed of Motor Vehicle (Exemption) (No. 5) Order, 2001.

(Under section 176 of the Traffic and Road Safety Act, 1998).

IN EXERCISE of the powers conferred upon the Minister responsible for works, housing and communications by section 176 of the Traffic and Road Safety Act, 1998, this Order is made this 7th day of May, 2001.

Act 15 of 1998.

1. This Order may be cited as the Traffic and Road Safety <sub>Citation</sub>. (Speed of Motor Vehicle) (Exemption) (No. 5) Order, 2001.

Exemption.

2. A person who drives a motor vehicle and who competes in the two days rally competition organised by the Federation of Motor Sports Clubs of Uganda (FMU) and described as the Simba Telecom Rally commencing on Friday 18th May, 2001 ending on Sunday 20th May, 2001 is exempted from the provisions of subsections (1) and (2) of section 121 of the Act for the duration of that rally.
