The Parliamentary Elections (District Women Representatives) Regulations, 2001.

(Under sections 11 and 99 of the Parliamentary Elections Ac 2001, Act No. 8 of 2001)

IN EXERCISE of the powers conferred upon the Minister by sections 11 and 99 of the Parliamentary Elections Act, 2001 and on the recommendation of the Electoral Commission and with the approval of Parliament, these Regulations are made this 9th day of May, 2001.

PART—PRELIMINARY.

1. These Regulations may be cited as the Parliamentary Elections (District Women Representatives) Regulations, 2001.

2. In these Regulations unless the context otherwise requires-

Interpretation.

"Act" means the Parliamentary Elections Act, 2001;

"Commission" means the Electoral Commission;

"currency point" has the value ascribed to it in the Act:

"election" means election of women representatives of districts to Parliament under these Regulations;

"electoral college" means an electoral college specified in paragraph (a) (ii) of subsection (3) of section 11 of the Act.

3. These Regulations shall apply to the election of district Application. women representatives, under paragraph (b) of clause (1) of article 78 of the Constitution.

PART II—THE ELECTIONS.

4. (1) The woman representative for every district shall be elected by the electoral college for that district.

Election of women representatives.

- (2) Except as provided expressly in these Regulations, the election of women representatives shall be conducted by the Commission in accordance with the provisions of the Act, with such modifications as the Commission shall direct.
- (3) Nothing shall prevent a contesting candidate from voting.

Register of

- 5. (1) For the purposes of the election of district women representatives the returning officer shall prepare a register of the members of the electoral college within each parish of the district.
- (2) A copy of the register-prepared under subregulation (1) shall be displayed in every parish for a period of at least seven days preceding polling day.
- (3) Any vacancy occurring in any Council or Committee which is a constituent part of the electoral college shall not affect the result of an election.

Campaigning. 6. For the purposes of campaigning by candidates for election as women representatives under these Regulations, section 21 of the Act shall apply with such modifications as the Commission shall direct.

Polling stations 7. Polling stations shall, for the purposes of the election of district women representatives, be at parish level.

Voting.

- **8.** (1) The voting procedure laid down in the provisions of the Act shall apply to the election of district women representatives.
- (2) Notwithstanding anything in subregulation (1), voting time for the purposes of the elections for district women representatives shall be between 9.00 a.m. and 5.00 p.m.

9. The Commission shall appoint nomination and polling days for elections under these Regulations.

Commission to appoint nomination and polling days.

10. For the avoidance of doubt, all persons nominated for election to Parliament as district women representatives under these Regulations must be persons qualified to be a member of Parliament in terms of article 80 of the Constitution and section 5 of the Act.

Educational and other qualifications for candidates.

11. A candidate for election as a district woman representative shall pay a non-refundable nomination fee of ten currency points as prescribed in subsection (2) of section 13 of the Act.

Nomination

12. All elections held under these Regulations shall be by secret ballot.

Voting to be by secret ballot.

PART III-MISCELLANEOUS.

13. (1) The Commission shall appoint returning officers, presiding officers and other election officers as may appear to the Commission reasonably necessary for the purpose of conducting the election of the representatives of women representatives in Parliament under these Regulations who shall have such functions as the Commission may direct.

Powers of the Commission.

- (2) The Commission may give such directions as may be necessary for ensuring that the elections are duly held for the purposes of these Regulations.
- 14. The Commission when appointing the dates for elections under these Regulations, shall take into account the provisions of clause (1) of article 81 of the Constitution.

Election dates.

15. (1) As soon as the election of a district woman representative for each district has been completed, the returning officer appointed under regulation 13 shall notify the Commission of the name of the representative elected by the electoral college.

Notification of results.

(2) The Commission shall, as soon as possible after receiving the results of elections under these Regulations, publish the results in the *Gazette* and communicate them to the Clerk to Parliament.

Commission to facilitate elections.

16. The Commission shall provide reasonable financial and other necessary assistance for purposes of conducting elections under these Regulations.

Penalties

17. Any person who-

- (a) refuses or without reasonable excuse fails to comply with any direction given by the Commission under these Regulations; or
- (b) obstructs the Commission or any returning officer, presiding officer or other election officer appointed by the Commission, in the carrying out of the functions of the Commission or such officer under the Act or these Regulations,

commits an offence and is liable on conviction to a fine not exceeding thirty currency points or imprisonment not exceeding one year or both.

Powers of Commission to make modifications. 18. The Commission shall conduct the elections under these Regulations in accordance with the Act with such modifications including modifications to prescribed forms as may be necessary.

(Under sections 11 and 99 of the Parliamentary Elections Act, 2001, Act No. 8 of 2001)

IN EXERCISE of the powers conferred upon the Minister by sections 11 and 99 of the Parliamentary Elections Act, 2001 and on the recommendation of the Electoral Commission and with the approval of Parliament, these Regulations are made this 14th day of May, 2001.

PART I—PRELIMINARY.

- 1. These Regulations may be cited as the Parliamentary Title. Elections (Special Interest Groups) Regulations, 2001.
- 2. In these Regulations, unless the context otherwise Interpretation.

"Act" means the Parliamentary Elections Act, 2001.

"election" means election of representatives of the special interest groups to Parliament under these Regulations;

"region" means a region specified in the First Schedule to these Regulations;

"special interest groups" means the groups referred to in article 78 (1)(c) of the Constitution;

"youth" means a person between eighteen and thirty years of age;

"Youth Statute" means the National Youth Council Statute, 1993.

PART II—REPRESENTATIVES OF THE UGANDA PEOPLES' DEFENCE FORCES.

Representatives of the UPDF. 3. The representatives of the Uganda Peoples' Defence Forces to Parliament shall be elected by the Uganda Peoples' Defence Forces Council in such manner and by such procedure as shall be determined by that Council.

PART III—REPRESENTATIVES OF THE YOUTH.

Regions

- 4. (1) For the purposes of the election of representatives of the youth in Parliament, Uganda shall be divided into four regions namely—
 - (i) the Northern Region;
 - (ii) the Eastern Region;
 - (iii) the Central Region; and
 - (iv) the Western Region.
- (2) The regions shall each comprise the areas of the districts specified in relation to them in the First Schedule to these Regulations.

Qualification for election.

- 5. (1) A person seeking to be elected as a representative of the youth in Parliament shall be a youth as defined in regulation 2 of these Regulations and also be qualified to be a member of Parliament in terms of article 80 of the Constitution and section 5 of the Act.
- (2) Subject to article 80 of the Constitution, and section 5 of the Act, election under these Rules shall be open to all youth:

6. All the members of District Youth Councils within each region shall constitute an electoral college for the election of the representative of the youth in Parliament for that region.


Electoral college within region of representation.

7. (1) The Commission shall appoint by notice published in the *Gazette* three days within which the electoral college of each region shall meet in their region to elect the representative of the youth for that region.

Election of representative of youth for each region

- (2) The nomination of a candidate for election under this regulation shall be made on a day appointed by the Commission on a form and in a manner approved by the Commission supported by two registered voters who are members of the electoral college and shall be accompanied by the nomination fee referred to in regulation 15 of these Regulations.
- 8. (1) The National Youth Conference for the election of the woman representative of the youth in Parliament shall comprise the following—

Electoral college for election of woman youth representative.



- (i) the Chairperson of every County Youth Council;
- (ii) the Chairperson of every District Youth Council;
- (iii) the Secretary for Women Youth at the District level; and
- (iv) eighteen students elected by the Uganda National Students Association;
- (b) one representative from each district elected by the members of the District Youth Council; and



- W DEVELOPAL
- (c) two student representatives elected for the purposes of this regulation, by the Uganda National Students Association, one of whom shall be female.

Election of woman youth representative.

- 9. (1) The Commission shall appoint, by notice published in the *Gazette*, three days within which the electroral college referred to in regulation 8 shall meet to elect the woman representative of the youth in Parliament.
- (2) The nomination of candidates for election under this regulation shall be made on a day appointed by the Commission and on a form and in a manner approved by the Commission supported by two registered voters who are members of the electoral college and shall be accompanied by the nomination fee referred to in regulation 15 of these Regulations.

PART IV—REPRESENTATIVES OF PERSONS WITH DISABILITIES.

Representatives of persons with disabilities. 10. The representatives of persons with disabilities in Parliament shall be elected by an electoral college consisting of four persons elected from each district from the organised associations and groups under the structure of the National Union of Disabled People of Uganda in that district.

Gender and disability balance. 11. In electing members of the electoral college under regulation 10, gender and disability balance shall be considered; and at least one of the four district representatives to the electoral college shall be a woman.

PART V-REPRESENTATIVES OF THE WORKERS.

Representatives of workers. 12. The representatives of the workers in Parliament shall be elected in accordance with the constitution of the Federation of Trade Union Organisations by the Annual Delegates' Conference which, under article 12 of that constitution consists of—



- (a) all members of NOTU Secretariat;
- (b) the permanent member of every NOTU affiliate organisation to the NOTU Central Governing Council:
- (c) the National Chairperson, General Secretary and Treasurer of every NOTU affiliated Union;
- (d) seven delegates selected by every NOTU affiliated Union.

PART VI-MISCELLANEOUS.

13. The Commission shall appoint nomination and polling days for elections under these Regulations.

Commission to appoint nomination and polling days.

14. For the avoidance of doubt, all persons nominated as candidates for election to Parliament under these Regulations must be persons qualified to be members of Parliament in terms of article 80 of the Constitution and section 5 of the Act.

Educational and other qualifications for candidates.

15. A candidate for election to Parliament under these Regulations shall pay a non-refundable nomination fee of ten currency points as prescribed in subsection (2) of section 13 of Act.

Nomination

16. All elections held under these Regulations shall be by secret ballot.

Voting to be by secret ballot.

17. (1) The Commission shall appoint returning officers, presiding officers and other election officers as may appear to the Commission reasonably necessary for the purpose of conducting elections under these Regulations who shall have such functions as the Commission shall direct.

Powers of the Commission

(2) The Commission may give such directions as may be necessary for ensuring that the elections are duly held for the purposes of these Regulations. Nomination and election dates. 18. The Commission when appointing the dates for nominations and elections under these Regulations shall take into account the provisions of clause (1) of article 81 of the Constitution.

Vacancies not to affect election results. 19. Any vacancy occurring in any office the holder of which is required to be a member of an electoral college under these Regulations for the purpose of any election shall not affect the result of the election.

Notification of results.

- 20. (1) As soon as the election of a representative of a special interest group is completed under these Regulations, the returning officer appointed under regulation 17 shall notify the Commission of the name of the representative elected in the form specified in the Second Schedule to these Regulations.
- (2) The Commission shall, as soon as possible after receiving the results of elections of representatives of special interest groups under these Regulations, publish the results in the *Gazette* and communicate them to Clerk to Parliament.

Commission to facilitate elections. 21. The Commission shall provide reasonable financial and other necessary assistance for purposes of conducting elections under these Regulations.

Penalties.

- 22. Any person who-
 - (a) refuses or without reasonable excuse fails to comply with any direction given by the Commission under these Regulations; or
 - (b) obstructs the Commission or any returning officer, presiding officer or other election officer appointed by the Commission, in the carrying out of the functions of the Commission or such officer under the Act or these Regulations,

commits an offence and is liable on conviction to a fine not exceeding thirty currency points or imprisonment not exceeding one year or both.

23. The Commission shall conduct the elections under these Regulations in accordance with the Act with such modifications, including modifications to prescribed forms as may be necessary.

Powers of Commission to make modifications.

24. The Parliamentary Elections (Special Interest Groups)
Regulations, 1996 and the Parliamentary Elections
(Representatives of the Youth in Parliament) Regulations 1996
are revoked.



THE PARLIAMENTARY ELECTIONS (AMENDMENT)
ACT, 2001.

An Act to amend the Parliamentary Elections Act, 2001 to provide for the election of district women representatives and to provide for the representation of the youth.

DATE OF ASSENT: 17th May, 2001.

Date of Commencement: 18th May, 2001.

BE IT ENACTED by Parliament as follows-

1. This Act may be cited as the Parliamentary Elections Amendment) Act, 2001.

Short title.

2. Section 11 of the Parliamentary Elections Act, 2001 is amended—

Amendment of section

- (a) in subsection (2) by substituting for paragraph (c) the following new paragraph—
 - "(c) for the youth there shall be five representatives at least one of whom shall be a woman:"
- (b) by substituting for subparagraph (iii) of subsection (3)(a) the following—

"(iii) subject to the provisions of this Act, the election of district women representatives may be held on a different day from the day on which the general election of members of Parliament elected directly to represent constituencies under paragraph (a) of clause (1) of article 78 of the Constitution is held;" and

(c) by substituting for paragraph (c) of subsection (3) the following new paragraph—

"(c) the representatives of the youth shall be elected in a manner prescribed by regulations made by the Minister under section 99 of this Act by the District youth Councils within the region of representation constituted into an electoral college in accordance with such regulations and the woman youth representative shall be elected by a national youth conference in accordance with the regulations.
