**The Traffic and Road Safety (Speed of Motor Vehicle)
(Exemption) (No. 7) Order, 2001.**

(Under section 176 of the Traffic and Road Safety Act, 1998).

IN EXERCISE of the powers conferred upon the Minister responsible for works, housing and communications by section 176 of the Traffic and Road Safety Act, 1998, this Order is made this 2nd day of August, 2001.

Act 15 of
1998.

1. This Order may be cited as the Traffic and Road Safety (Speed of Motor Vehicle) (Exemption) (No. 7) Order, 2001.

Citation.

2. A person who drives a motor vehicle and who competes in the three days rally competition organised by the Federation of Motor Sports Clubs of Uganda (FMU) in conjunction with the Uganda Motor Club (UMC) and described as the DFCU Motor Rally commencing on Friday 10th August, 2001 and ending on Sunday 12th August, 2001 is exempted from the provisions of subsections (1) and (2) of section 121 of the Act for the duration of that rally.
