IN EXERCISE of the powers conferred on the Minister responsible for the reform and divestiture of public enterprises by sections 25A (1) and 26 (4) of the Public Enterprises Reform and Divestiture Statute, 1993, this Instrument is made this 17th day of December, 2001.

1. This Instrument may be cited as the Public Enterprises Reform and Divestiture (Vesting of Undertaking of the Uganda Electricity Board) (No. 2) Instrument, 2001.

2. (1) The 17th day of December, 2001 is appointed to be the date on which the undertaking specified in the Schedule which, before the commencement of this Instrument was vested in the Uganda Electricity Board, shall vest in its successor company, the Uganda Electricity Transmission Company Limited.

**The Land Acquisition (Land Situated Around the Bujagali
Hydro Electric Power Project Area) Instrument, 2001.**

(Made under section 2 of the Land Acquisition, 1965, Act No. 14 of 1965).

IN EXERCISE of the powers conferred upon the Minister by subsection (1) of section 2 of the Land Acquisition Act, 1965, this Instrument is made this 6th day of December, 2001.

Act No. 14
of 1965.

1. This Instrument may be cited as the Land Acquisition (Land Situated Around the Bujagali Hydro Electric Power Project Area) Instrument, 2001.

Citation.

2. The area of land situated around Bujagali Hydro Electric Power Project comprising 450 hectares described in the schedule to this Instrument is declared to be land required by the Government for a public use.

SCHEDULE

DESCRIPTION OF THE LAND TO BE ACQUIRED FOR THE BUJAGALI HYDRO-ELECTRIC POWER PROJECT

The land to be acquired for the Bujagali Hydro-power Project, straddles Dumbbell Island and both banks of the Nile River within the sub-counties of Budondo on the east bank and Wakisi on the western bank. Dumbbell Island is situated some 8km downstream of the Owen Falls Hydroelectric facility.

On the Western Bank of the Nile River, in Mukono District, starting at the Northern end, from 514800E, 56200N at the edge of the Nile River in a south westerly direction some 450m to co-ordinates 514630E, 55600N some 260m apart on land in Kikubamutwe village. Running in a southerly direction some 450m to co-ordinates 514790E, 55590N the line defining the land to be acquired now runs in a westerly direction for some 380m to a point 514580E, 55510N and in a southerly direction to a point with co-ordinates 514700E, 554810N a distance of 460m. Between the last two coordinates a 30m wide access road of length some 200m will connect with the main highway at 514330E, 55180N.

From S15 the line demarcating the extent of landtake traverses in an easterly direction through the village hinterland of Malindi some 460m to a point S16 located at co-ordinates 515110E, 54920N then running in a southerly direction a distance of 100m to point S17 at 515140E, 54830N. The line then extends in an easterly direction to a point S18 at co-ordinates 5515260E, 54850N a distance of approximately 125m.

From this point the line follows the 1116m contours extending into the village of Buloba to a point with co-ordinates 516320E, 554320N a distance of 1200m in the southwesterly direction. From this point the line extends in a southerly direction to a point 51680E, 53610N a distance of 800m. Then the boundary of the land to be acquired enters into Naminya village to point 5517640E, 52630N a distance of 1,400m. This boundary point is the extent of land to be acquired on the western bank of the Nile.

In the district of Jinja on the eastern bank of the Nile from the southerly boundary point in the village of Naminya on the west bank the starting point location for land to be acquired on the east bank for the project is a distance of some 1200m across the river Nile to a point located at co-ordinates 517995E, 53770N. This point lies on the 116m contour line in the Bujagali picnic area in the village of Kyabirwa in the sub-county of Budundo. The extent of the land to be acquired follows for the most part the 1116 contour line firstly in a westerly direction to a point 517730E, 53660N a distance of some 500m. The land acquisition line then heads in a northerly direction along the 116m contour through the hinterland of Kyabira village to a point 516200E, 54830N a distance of some 2.0km. The acquisition line then traverses in a westerly direction to a point 516910E, 55135N a distance of 800m. Running from this point in a northeasterly direction a distance of 320m to its furthest easterly point at co-ordinates 517055E, 55420N the line crosses into the village area of Namizi West from Kyabirwa. Along this traverse a temporary access road of some 30m width and 2km in length heading in an easterly direction through the village of Budhagali and Ivanumba to converge with the state highway will fall within the extent of land to be acquired.

From the last stated co-ordinates in the village area of Namizi West the line extends in a north-easterly direction a distance of 140m to co-ordinates 516945E, 55495N. The acquisition line extends due west a distance of some 420m to a point at co-ordinates 516560E, 55330N. From this point the line traverse in a north easterly direction to co-ordinates 515385E, 56490N a distance of some 1660m and crosses from Namizi West into the village of Buyala. The boundary of the land reaches the edge of the River Nile at the east bank most northerly co-ordinates at 515055E, 56313N after traversing in a westerly direction a distance of 430m, directly across the northerly starting point in Kikubamutwe village.

The total area including the surface area of the existing river amounts to some 450ha.
