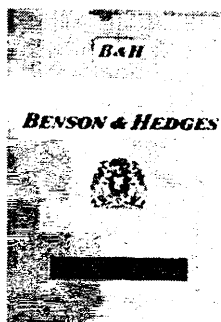

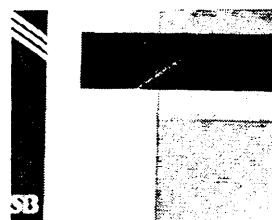

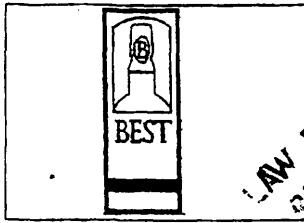

The Local Governments Graduated Tax (Declaration of Rates) Instrument, 2002.

IN EXERCISE of the powers conferred upon the Minister by subsection (5) of section 81 of the Local Governments Act, 1997 and in consultation with the Minister responsible for finance, this Instrument is made this 20th day of March, 2002.

1. This Instrument may be cited as the Local Governments Graduated Tax (Declaration of Rates) Instrument, 2002. Citation.

2. The rate of graduated tax which shall be imposed by a local government in respect of an annual amount of income specified in column 1 of the Schedule to this Instrument is that specified in column 2 of that Schedule in relation to that annual amount. Rate of Graduated Tax on people living below the poverty line.

3. (1) The maximum rate of graduated tax which shall be imposed by every local government in Uganda on people living below the poverty line shall be three thousand shillings per year. Rate of Graduated Tax.

(2) For the purpose of subsection (1) a person is deemed to live below the poverty line if he or she does not earn more than 288,000 shillings in a year.

4. (1) The Local Governments Graduated Tax (Declaration of Rates) Instrument, 2001 is revoked. Revocation of S.I. No. 52 of 2001.
