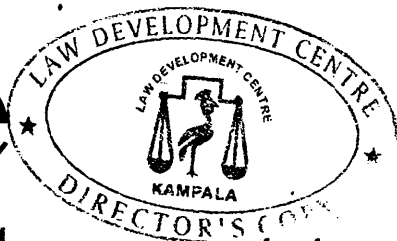

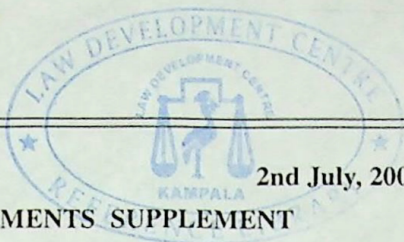

The External Trade (Importation Licence) (No. 8) Order, 2002.

(Made under section 5A of the External Trade Act, Cap. 103)

IN EXERCISE of the powers conferred upon the Minister by section 5A of the External Trade Act, this Order is made this 1st day of July, 2002. Cap. 103.

1. This Order may be cited as the External Trade (Importation Licence) (No. 8) Order, 2002. Citation.

2. (1) The person listed in column 1 of the Schedule is granted exclusive licence to import used tyres of different sizes, in the quantities listed in column 2 of the Schedule. Grant of exclusive licence.

(2) The exclusive licence referred to in sub-paragraph (1) shall be valid for the one year only and if the licence expires before the importer has imported the number of used tyres authorised by the licence, the importer shall forfeit the balance of the tyres not imported.
