

Vella Muheigwe sat for Uganda Certificate of Education in 1989 (U0381/003) and the Uganda Advanced Certificate of Education in 1997 (U0087/767) impersonating Kajungu Henry. While entry forms for both examinations indicate the candidate as male, the impersonator was female to the knowledge of the then Headteachers of Nyakabungo Girls Boarding School and Kololo High School.

Vella Muheigwe changed her sex to female on joining Makerere University, Kampala where she studied B.A Soc (Cand.97/U/1775) as established by CRB 1395/2001 at Kira Road Police Station.

This is to cancel the results for U0381/003 UCE 1989 and U0087/767 UACE 1997.







2. These Regulations shall be deemed to have come into force on the 1st day of July, 1999. Commencement.



1. This Order may be cited as the External Trade (Importation Licence) (No. 9) Order, 2002. Citation.

2. (1) The person listed in column 1 of the Schedule is granted exclusive licence to import used tyres of different sizes in the quantities listed in column 2 of the Schedule. Grant of exclusive licence.

(2) The exclusive licence referred to in sub-paragraph (1) shall be valid for the one year only and if the licence expires before a person has imported the number of used tyres authorised by the licence, that person shall forfeit the balance of the tyres not imported.
