Prohibition of certain nets and methods 7A The following nets and fishing methods are prohibited in any waters of Uganda, unless authorised in writing by the Chief Fisheries Officer—

- (a) Cast-nets;
- (b) Monofilament nets;

- (c) beating or splashing of water commonly known as "kikubo" or tycoon with an intention of scaring or driving fish into a net or any other appliance with intention to capture the fish;
- (d) trawl-nets or presence of trawlers on any water body;
- (e) long lines with hooks whose size is above size nine.

Fish movement permit

- 7B (1) A person shall not for purposes of trade, move fish or fish products from one place to another unless—
 - (a) he or she is in possession of a valid movement permit issued by an authorised officer; or
 - (b) he or she is a licensed fisherman; or
 - (c) he or she is a fish farmer.
- (2) The fish movement permit shall be in the form set out in the schedule to these Rules.
- (3) The fees to be charged for the fish movement permit shall be Ushs. 10 per kg of fresh fish and Ushs. 20 per kg of dry weight.
- (4) The holder of a fish movement permit shall cause the permit to be carried and exhibited at all times.
- (5) The fish movement permit shall not be transferred from one person to another or used for any other vehicle or vessel or used for any other batch or consignment of fish other than the one for which it was issued.

Manufacture, sale and importation of fishing gears. 7C A person shall not manufacture, import or display for sale any nets or fishing appliances, which are prohibited unless authorised in writing by the Chief Fisheries Officer.
