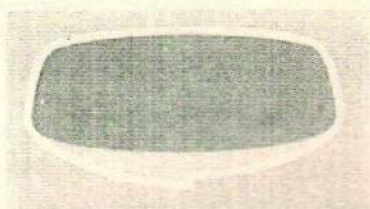

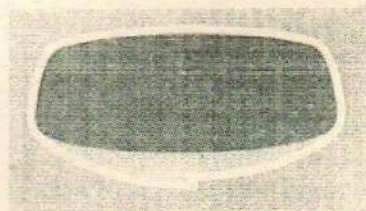

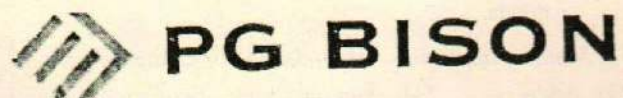

1. This Order may be cited as the Traffic and Road Safety (Speed of Motor Vehicle) (Exemption) Order, 2003.

Citation.

2. A person who drives a motor vehicle and who competes in the Mbarara Motor Club (MMC) competition organised by the Federation of Motor Sports Club of Uganda, commencing on the 21st and ending on the 23rd February, 2003 is exempted from the provisions of subsections (1) and (2) of section 121 of the Traffic and Road Safety Act, for the duration of that rally.
