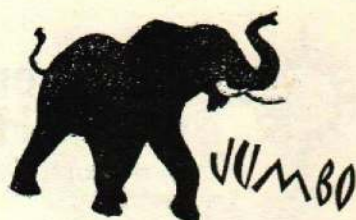

**The National Women's Councils and Committees
(Elections) (Amendment) (No. 2) Regulations, 2003.**

1. These Regulations may be cited as the National Women's Councils and Committees (Elections) (Amendment) (No. 2) Regulations, 2003.

Citation.

2. The National Women's Councils and Committees (Elections) Regulations, 1993 is amended in regulation 22 by substituting for sub-regulation (6) the following new sub-regulation—

“(6) For the avoidance of doubt, no candidate shall be declared a winner unless she has obtained a simple majority of the members present and voting or has been elected unopposed.”
