The External Trade (Importation Licence)(No. 5) Order, 2003.

(Made under section 5A of the External Trade Act, Cap. 103).

IN EXERCISE of the powers conferred upon the Minister by section 5A of the External Trade Act, this Order is made this 27th day of August, 2003. Cap. 103.

1. This Order may be cited as the External Trade (Importation Licence)(No. 5) Order, 2003. Citation.

2. (1) The person specified in column 1 of the Schedule to this Order is granted an exclusive licence to import used tyres of different sizes in the quantities specified in column 2 of the Schedule. Grant of exclusive licence.

(2) The exclusive licence referred to in sub-paragraph (1) is valid for six months only and if the licence expires before a person has imported the number of used tyres authorised by the licence, that person shall forfeit the balance of the tyres not imported.
