- (f) In section 21(2) by substituting for the words, "twenty percent" the words, "thirty percent".

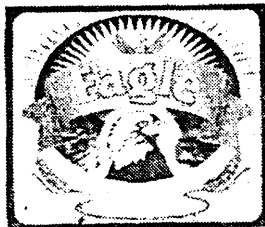
