APPOINTMENT OF TIME AND PLACE FOR  
TALLYING OF VOTES CAST IN THE LOCAL  
GOVERNMENT COUNCILS FOR NEWLY CREATED  
SUB-COUNTIES/TOWN COUNCILS.

NOTICE IS HEREBY GIVEN by the Electoral Commission subject to Section 53 of the Local Governments (Amendment) Act No. 13 of 2001 and in accordance with Section 19(1)(b) of the Parliamentary Elections Act, No 8 of 2001, the Commission, for purposes of the Local Government Council in the hereunder specified newly created Sub-counties/Town Councils:

- directs that the time appointed for tallying by the Returning Officer of the number of votes given to each candidate from each polling station shall be as soon as practicable on receiving the declaration of the results form in respect of each polling station within the Sub-county/Town Council; and
- appoints the Headquarters of the respective sub-counties/Town Councils to be the place for tallying the votes cast in favour of each candidate from each polling station within each constituency as follows:

(a) Butanda	Butanda	Kabale;
(b) Kinyogoga	Kinyogoga	Luweero;
(c) Mbare	Mbare	Mbarara;
(d) Biharwe	Biharwe	Mbarara; and
(e) Wakiso T.C	Wakiso T.C	Wakiso.
