





2. The Uganda Peoples' Defence Forces (Conditions of Service) (Officers) Regulations 1993 are amended in regulation 28 by adding the following new sub-regulation:

"(4) The High Command may, when satisfied that a retiring officer has rendered invaluable and meritorious service to the Defence Forces and the country;

(a) make special arrangements for his or her retirement including, but not limited to, security arrangements depending on the prevailing conditions.


