



# STATUTORY INSTRUMENTS 2004 No. 9.

# The External Trade (Prohibition of Importation of Certain Batteries) Order, 2004.

(Made under section 7 of the External Trade Act, Cap. 103).

IN EXERCISE of the powers conferred upon the Minister, by section 7 of the External Trade Act, this Order is made this 2nd day – cap. 103. of September, 2003.

**1.** This Order may be cited as the External Trade Citation. (Prohibition of Importation of Certain Batteries) Order. 2004.

2. No person shall import batteries of a type or category listed in the Schedule to this Order, three months after the coming into force of this Order.

Prohibition of Importation of Batteries.

Offences.

**3.** A person who imports a product specified in the Schedule to this Order after the date specified in section 2 commits an offence and is liable, on conviction, to the penalties prescribed inder sections 11 and 12 of the External Trade Act.
