CONSTRUCTION OF THE KAMPALA NORTHERN BYPASS

NOTICE OF COMMENCEMENT AND HANDOVER OF SITE

RECALLING the Ministry of Works, Housing and Communications, represented by the Road Agency Formation Unit (RAFU), undertook, through the consultancy services of BCEOM Consultant, a Public Inquiry on the Kampala Northern Bypass in April-June 2001, and an additional Public Inquiry in the vicinity of Bethany High School in September/November 2001;

WHEREAS the said Ministry caused the consultant to produce sets of maps at a scale of 1:2,500, showing the 'Recommended Alignment', together with a summary of the consultant's report on the Public Inquiry, which were widely displayed for public viewing;

WHEREAS the Ministry of Works, Housing and Communications on the 17th of September, 2001 did issue Informative/Notices about the Kampala Northern Bypass in the New Vision of the 16th September, 2001 and in other print media;

WHEREAS the Ministry of Works, Housing and Communications issued a Press Release on 20 September 2002 in the New Vision Newspaper requesting the people affected by the "Final Alignment" to view the final set of maps (at a scale of 1:2,500) placed on public display at various points including but not limited to RAFU Offices to check on the "Final Alignment" and the corresponding land to be acquired, to conclude the public consultation process;

WHEREAS the Minister of Water, Lands and Environment through Statutory Instrument No. 1 of 2003, in an order gazetted as The Town and Country Planning (Declaration of Planning Area) Order, 2003 did specify the Planning Area

for the Kampala Northern Bypass and the Statutory Instrument was placed for Public viewing at various points including but not limited to RAFU Offices;

AND WHEREAS the Ministry of Works, Housing and Communications, issued a Public Notice through the New Vision Newspaper on the Gazettement of the Planning Area on the 10th day of January, 2003;

NOW THEREFORE RECALLING, the Briefing Meetings, from 2001 for the identification of alternative alignments for the Road, the Public Consultative meetings from 2001 at various locations and touching differing subjects of the Public Inquiries, Receipt of Public Memoranda, the Independent third party checks to ensure transparency and conclusively marking the "Final Alignment," the gazetting of the planning area, the cadastral surveys, valuation surveys in preparation for the acquisition of land for the Kampala Northern Bypass and identification of the compensation beneficiaries;

NOTICE IS HEREBY GIVEN that performance of the contract for construction of the Kampala Northern Bypass, commenced on Thursday 20 May 2004 and that Government is now obliged to immediately hand over the site for the Kampala Northern Bypass to the contractor to start the road works;

NOTICE IS ALSO HEREBY GIVEN that the road works have commenced over sections of the Final Alignment of the Kampala Northern Bypass by M/s Salini Costruttori S.P.A., the road works contractor;

Proceeds of Transaction: • Concession fee of US\$ 1,200,000, being a one time payment;
• 4% of gross revenues to be paid quarterly in advance, and
• Depreciation of NHIL's assets.

Additional information: STPS's bid was evaluated on the basis of its proposed investment as follows:

- US\$ 19 million in phase I to be completed in 2005, and
- A further US\$ 10.6 million in phase 2 to be completed in the year 2006/2007.

- The investment is for refurbishment and development of the existing assets and to provide other additional amenities and expansion of the number of hotel rooms, the end product being a five star hotel at the International Conference Centre.
- At the end of the concession, all assets will revert back to NHIL.
