NOTICE OF INTENDED APPLICATION FOR A LICENSE FOR GENERATION AND SALE OF ELECTRICITY

The Electricity Regulatory Authority has under section 29 of the Electricity Act 1999, received a notification for intended application for a license from Statkraft Norfund Power Invest AS (SN Power) for the generation and sale of electricity.

SN Power intends to install four Hydro Power Plants along rivers as described below:

- Muzizi Hydro Power Project (HPP): 10 or 20 MW on River Muzizi in Kabarole District; 58km of 33 or 132kV line to Fort Portal.
- Nengo Bridge HPP:- 7.5MW, 8-9 km downstream of Nengo Bridge on Mitano River bordering Rukungiri and Kanungu Districts; 21km of 33kV line to Rukungiri.
- Bugoye HPP:- IIMW, Bugoye (Mubuku II) on River Mubuku in Kasese and evacuation of power to Nkenda substation via a 4km 33kV line.
- o Waki HPP:- 5MW, Waki River, providing power to electrify the local area in Masindi and Hoima Districts; excess power to be evacuated to the grid with a proposed power line from Butiaba through Bukumi and Biso to Kigorobya via a 40km 33kV line.

Anticipated scope for SN Power includes installation of the above four Hydro Power Plants and supply of power to local areas in Masindi and Hoima Districts.
