**The External Trade (Importation Licence) (No. 7) Order, 2005.**

*(Under section 5 of the External Trade Act, Cap. 88).*

IN EXERCISE of the powers conferred on the Minister by section 5 of the External Trade Act, this Order is made this 18th day of February, 2005. Cap. 88.

1. This Order may be cited as the External Trade (Importation Licence) (No. 7) Order, 2005. Title.

2. (1) M/s Mwakana General Traders & Suppliers of P. O. Box 362, Kampala is granted an exclusive licence to import five thousand pieces of used tyres. Grant of exclusive licence.

(2) The exclusive licence referred to in subparagraph (1) is valid for six months only from the commencement of this Order and shall then expire.

(3) Where the licence expires before a person has imported the number of used tyres authorised by the licence, that person shall forfeit the balance of the tyres not imported.
