The Public Procurement and Disposal of Public Assets Authority (PPDA) is established under Act 1 of 2003 to supervise and regulate all public procurement and disposal activities of procuring and disposing entities. Under Section 7 of the PPDA Act, the Authority is required to issue guidelines from time to time to these entities for the better carrying out of the objectives of the Act.

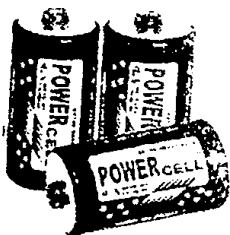


