**The External Trade (Import Licence) (Tiger Head Brand
Batteries) Order, 2006.**

(Under section 5 of the External Trade Act, Cap 88)

IN EXERCISE of the powers conferred on the Minister by section 5 of the External Trade Act, this Order is made this 3rd day of January, 2006. Cap. 88.

1. This Order may be cited as the External Trade (Import Licence) (Tiger Head Brand Batteries) Order, 2006. Title.

2. (1) M/s Frama Enterprises Limited, P.O. Box 11173, Kampala, is granted a licence to import 6,000 cartons of Tiger Head Batteries from M/s Guangzhou Tiger Head Brand Battery Group Company Ltd, China. Grant of exclusive licence.

(2) The licence referred to in subparagraph (1) is valid for a period of six months from the date of publication of this Instrument and shall then expire.
