# The External Trade (Import Licence) (Tiger Head Brand Batteries) Order, 2006.

(Under section 5 of the External Trade Act, Cap 88)

IN EXERCISE of the powers conferred on the Minister by section 5 of the External Trade Act, this Order is made this 3rd day of January, 2006.

- 1. This Order may be cited as the External Trade (Import Licence) (Tiger Head Brand Batteries) Order, 2006.
- 2. (1) M/s Frama Enterprises Limited, P.O. Box 11173, Kampala, is granted a licence to import 6,000 cartons of Tiger Head Batteries from M/s Guangzhou Tiger Head Brand Battery Group Company Ltd, China.

Grant of exclusive licence.

(2) The licence referred to in subparagraph (1) is valid for a period of six months from the date of publication of this Instrument and shall then expire.
