THE PARLIAMENTARY ELECTIONS (AMENDMENT) ACT, 2006

An Act to amend section 8(3) of the Parliamentary Elections Act, 2005.

DATE OF ASSENT: 5th January, 2006.

Date of commencement:5th January, 2006.

BE IT ENACTED by Parliament as follows:

1. Amendment of section 8 of the Parliamentary Elections Act 2005

Section 8 of the Parliamentary Elections Act 2005 is amended in subsection (3) by substituting for the words "supported by not less than two thirds of all members of Parliament", the words—

"supported by a simple majority of members of Parliament".
