

The Capital Markets Authority (Cross Border Introductions) (Amendment) Regulations, 2006.

(Under section 101 of the Capital Markets Authority Act, Cap. 84)

IN EXERCISE of the powers conferred on the Capital Markets Authority by section 101 of the Capital Markets Authority Act, Cap. 84. these Regulations are made this 31st day of January, 2006.

Title and

1. (1) These Regulations shall be cited as the Capital Markets Authority (Cross Border Introductions) (Amendment) Title and Commencement. Regulations, 2006.

(2) These Regulations shall be deemed to have come into force on the 15th day of November, 2005.

2. The Third Schedule of the Capital Markets Authority (Cross Border Introductions) Regulations, 2004 is amende by substituting for U. Shs. 25,000,000, the fee of U. Shs. 10,000,000, for the lodgement of an information memorandum for an introduction.
