**The Traffic and Road Safety (Speed of Motor Vehicle)  
(Exemption) (No. 4) Order, 2006.**

*(Under section 175 of the Traffic and Road Safety Act, Cap 361).*

IN EXERCISE of the powers conferred upon the Minister responsible for works and transport by section 175 of the Traffic and Road Safety Act, this Order is made this 14th day of September, 2006.
