

The Traffic and Road Safety (Speed of Motor Vehicle) (Exemption) (No. 5) Order, 2006.

(Under section 175 of the Traffic and Road Safety Act, Cap 361).

IN EXERCISE of the powers conferred upon the Minister responsible for works and transport by section 175 of the Traffic and Road Safety Act, this Order is made this 14th day of September, 2006.

1. This Order may be cited as the Traffic and Road Safety (Speed of Motor Vehicle) (Exemption) (No. 5) Order, 2006.

Title.

2. A person who drives a motor vehicle and who competes in the UMC Independence Rally, organised by the Federation of Motor Sports Club of Uganda and the Uganda Motor Club, commencing on the 20th October, 2006 and ending on the 22nd October, 2006 is exempted from the provisions of section 120 of the Traffic and Road Safety Act, for the duration of that rally.
