THE UGANDA COMMUNICATIONS ACT. CAP. 106, LAWS OF UGANDA

(Section 11 (1) and (2) of the Uganda Communications Act)

THE COMMUNICATIONS (TELECOMMUNICATIONS INFRASTRUCTURE) GUIDELINES, 2006

Following the end of the exclusivity period for the two National Operators, UTL and MTN on 24th July, 2005, the Telecommunications Policy Guidelines were issued on 11th May, 2006, to guide the sector and in turn, a new Telecommunication Licensing regime, became effective on 14th August, 2006.

Whereas the 11th May, 2006 Policy Guidelines gave sector direction in respect of only telecommunications service provision and not telecommunications infrastructure provision.

And whereas further consultations have revealed that it is imperative that the sector be opened up fully for infrastructure provision. Now therefore, in exercise of the powers conferred upoe the Minister responsible for communication by Section 11(1) of the Uganda Communications Act, Cap. 106. Laws of Uganda, these Guidelines are issued to the Uganda Communications Commission on this 13th day of October. 2006.

The Uganda Communications Commission will under the mandate granted to it by the Uganda Communications Act. make recommendation to the Minister in respect of the grant of infrastructure licenses and shall accordingly follow the Guidelines below:

(i) Open the infrastructure provision to full competition. This means that investors can now apply to get licences to provide infrastructure.

(ii) In the context of these guidelines, infrastructure refers to plant, equipment and systems associated with the transmission, receptore and switching of advergencements (electrozic) signals.

(iii) Grant anterested appearants additionation lineares, service liceaces or both as long as the scientif only and regulatory requirements are not.

(iv) Licensing of wireless based infrastructure will depend on the availability of spectrum.

(v) Ensure that operations of both existing and new entrants are in conformity with the principles of fair competition in regard to each other and in regard to each Service providers.

(vi) Recognise and provide for the right of the private individuals or entities to put in place their own private infrastructure, if they so wish.

(vii) Follow the principle of technology neutrality in granting the Licences.

Further, in exercise of the powers conferred upon the Minister responsible for communication by Section 11(1) of the Uganda Communications Act, Cap. 106. Laws of Uganda, the Minister reserves the right to review these Guidelines as and when the need arises.







1. This Order may be cited as the National Social _{Citation}. Security Fund (Interest on Benefits) Order, 2006.

Declaration.

2. All Benefits payable out of the National Social Security Fund for the financial year 2005/2006 shall carry an annual interest rate of seven per centum (7%) calculated on the balance standing to the credit of the members' accounts on the first day of July, 2005.
