IN EXERCISE of the powers conferred upon the Electoral Commission by section 19(8)(c) of the Electoral Commission Act, this Instrument is made this 21st day of November, 2006.

Title.

- 1. This Instrument may be cited as the Electoral Commission (Appointment of Date of Completion of Update of Voters' Register in Apac District) Instrument, 2006.
- 2. The 22nd day of November, 2006, is hereby appointed as the date upon which the Commission shall complete the exercise of updating the Voters' Register for purposes of the by-election in Apac District.

Appointment of date of completion.

3. For purposes of paragraph 2 of this Instrument, after the appointed date, no application form from Apac District shall be accepted by the Electoral Commission, seeking—

No application accepted after appointed date.

- (a) to register as a voter; or
- (b) to transfer to a new voting location.

The Uganda National Roads Authority Act, 2006 (Commencement) Instrument, 2006.

(Under section 1 of the Uganda National Roads Authority Act, 2006, Act No. 15 of 2006)

IN EXERCISE of the powers conferred upon the Minister by section 1 of the Uganda National Roads Authority Act, 2006, this Instrument is made this 10th day of November, 2006.

- 1. This Instrument may be cited as the Uganda National Title Roads Authority Act, 2006 (Commencement) Instrument, 2006.
- 2. The 1st day of December, 2006 is appointed as the date on which the Uganda National Roads Authority Act, 2006 shall come into force.
