



(Under section 10(a) of the Stamps Act, Cap. 342).

IN EXERCISE of the powers conferred on the Minister responsible for finance by section 10(a) of the Stamps Act, this Instrument is made this 11th day of April, 2007.

1. Title.

This Instrument may be cited as the Stamps (Exemption from Stamp Duty) (Lease of Land to Foundation of St. Raphael of Mount Tabor) Instrument, 2007.

2. Exemption from stamp duty.

The stamp duty chargeable under the provisions of section 2 of the Act on the lease of land comprised in Plots 3-11, Third Ring Road, Luzira by Uganda Land Commission to Foundation of St. Raphael of Mount Tabor is exempted.
