**The Electoral Commission (Appointment of Date of Completion of Update of Voters' Register in Bugweri County Constituency, Iganga District) Instrument, 2007.**

*(Under Section 19(8)(b) of the Electoral Commission Act, Cap 140).*

IN EXERCISE of the powers conferred upon the Minister under section 19(8)(b) of the Electoral Commission Act, Cap 140, this Instrument is made this 23rd day of October, 2007.

**1. Title.**

This Instrument may be cited as the Electoral Commission (Appointment of Date of Completion of Update of Voters' Register in Bugweri County Constituency, Iganga District) Instrument, 2007.

**2. Appointment of completion date.**

The 26th day of October, 2007, is hereby appointed as the date upon which the Commission shall complete the exercise of updating the Voters' Register for purposes of the by-election in Bugweri County Constituency, Iganga District.
