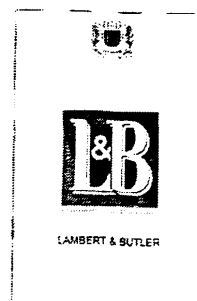

This Instrument may be cited as the Electoral Commission (Appointment of Date of Completion of Update of Voters' Register in Specified Electoral Areas, Mukono District) Instrument, 2008 and shall be deemed to have come into force on the 11th day of March, 2008.

2. Appointment of date of completion.

The 17th day of March, 2008, is hereby appointed the date upon which the Commission shall complete the exercise of updating the Voters' Register for purposes of the by-election in—

- (a) Mubembe Parish, Koome Sub-county;
- (b) Busanga Parish, Koome Sub-county;
- (c) Binga Parish, Ssi Sub-county; and
- (d) Namulesa Parish, Ngogwe Sub-county.

3. No application accepted after appointed date.

For purposes of paragraph 2 of this Instrument, after the appointed date, no application form from the specified Electoral Areas, Mukono District shall be accepted by the Electoral Commission, seeking—

- (a) to register as a voter; or
- (b) to transfer to a new voting location.
