The Traffic and Road Safety (Speed of Motor Vehicle) (Exemption)
(No. 4) Order, 2008.

(Under section 175 of the Traffic and Road Safety Act, Cap 361).

IN EXERCISE of the powers conferred upon the Minister responsible for transport by section 175 of the Traffic and Road Safety Act, Cap. 361 this Order is made this 25th day of July, 2008.

1. Title.

This Order may be cited as the Traffic and Road Safety (Speed of Motor Vehicle) (Exemption) (No. 4) Order, 2008.

2. Exemption.

A person who drives a motor vehicle and who competes in the United Motor Sports Club (UMOSPOC) challenge rally, organised by the ederation of Motor Sports Club of Uganda (FMU), commencing on the 8th August, 2008 and ending on the 10th August, 2008 and passing through the Districts of Kampala, Wakiso, Mukono and Kayunga is exempted from the provisions of section 120 of the Traffic and Road Safety Act. for the duration of that rally.
