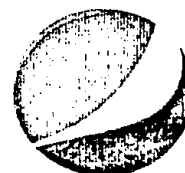

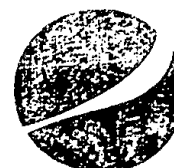

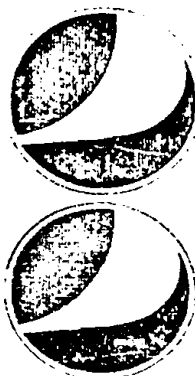

2. Commencement.

These Regulations shall come into force on 15th October, 2009.
