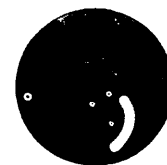

IN EXERCISE of the powers conferred upon the Minister responsible for transport by section 175 of the Traffic and Road Safety Act, Cap. 361, this Order is made this 5th day of February, 2010.

**1. Title.**

This Order may be cited as the Traffic and Road Safety (Speed of Motor Vehicle) (Exemption) (No. 3) Order, 2010.

**2. Exemption.**

A person who drives a motor vehicle and competes in the Mbarara Rally - 2010 organized by the Federation of Motor Sports Clubs of Uganda (FMU) scheduled to take place on the 5th to 7th March 2010 running through the districts of Mbarara, Kiruhura and Bushenyi is exempted from the provisions of section 120 of the Traffic and Road Safety Act, Cap. 361.

**3. Maximum speed limit.**

A person who drives a motor vehicle and competes in the Mbarara Rally - 2010 mentioned in paragraph 2, shall not exceed a maximum speed limit of two hundred kilometers per hour, for the duration of the rally.
