



**The Traffic And Road Safety Act (Closure of Road) (Exemption)  
Order, 2010.**

*(Under section 175 of the Traffic and Road Safety Act, Cap. 361).*

IN EXERCISE of the powers conferred upon the Minister of Works and Transport by section 175 of the Traffic and Road Safety Act 1998, Cap. 316 this Order is made this 16th day of March, 2010.

**1. Title.**

This order may be cited as the Traffic and Road Safety (Closure of Road) (Exemption) Order, 2010.

**2. Exemption.**

A person who takes part in the Annual Easter (Smirnoff) Street Jam Promotion 2010 organised by Club Silk commencing on the 1st May, 2010 to 2nd May, 2010 on 1st Street Industrial Area, Kampala is exempted from the provisions of section 136 of the Traffic and Road Safety Act for the duration of the Street Jam Promotion.
