# SPEAKER OF THE PARLIAMENT OF THE REPUBLIC OF UGANDA

Whereas clause (3) of Article 95 of the Constitution of the Republic of Uganda provides that the Speaker may after consultation with the President, prorogue Parliament by proclamation:

AND WHEREAS the necessary consultation with His Excellency the President has been carried out and it has been agreed that Parliament be prorogued:

Now THEREFORE, in exercise of the powers conferred on the Speaker by clause (3) of Article 95 of the Constitution of the Republic of Uganda, it is proclaimed that Parliament shall stand prorogued with effect from the 20th day of May 2010. The pending business in the House or its Committees is saved.
