**The Amnesty Act (Extension of Expiry Period)  
Instrument, 2010.**

*(Under section 16 of the Amnesty Act Cap. 294)*

IN EXERCISE of the powers conferred upon the Minister by section 16 of the Amnesty Act, this Instrument is made this 5th day of May, 2010.

**1. Title and commencement.**

(1) This Instrument may be cited as the Amnesty Act (Extension of Expiry Period) Instrument, 2010.

(2) This Instrument shall come into force on the 25th day of May, 2010.

**2. Extension of expiry period.**

The expiry period of the Amnesty Act is extended for a period of twenty four months.
