NOTICE OF GRANT OF FERRY LICENCE

IT IS HEREBY NOTIFIED that a Ferry Licence has been granted in accordance with the provisions of Section 4(1) of the Inland Water Transport (Control) Act, Cap. 356 to Kalangala Infrastructure Services Limited of P.O. Box 35501, Kampala for an exclusive period of eight years from the in-service date. The Routes subject to the Ferry Licence are directly between Bukakata and Luku Point (Bugoma) (exclusive) and directly or indirectly between any of Bukakata, Luku Point (Bugoma), Bwendero or Mulabana Landing Sites or any other point on Bugala Island (exclusive).

The compressed version of the Licence is as published hereto and the entire Licence is available for inspection at the offices of Ministry of Works & Transport and Kalangala Infrastructure Services Ltd.

FERRY LICENCE AGREEMENT

For provision of maritime transportation services between Bugala Island (Kalangala District) and the mainland using two new ferries.

Dated:	18th December, 2009
Parties:	(1) The Government of the Republic of Uganda, represented by the Ministry of Works and Transport. (2) Kalangala Infrastructure Services Limited, a Ugandan limited company as "Licensee".
Term	8 years from the date on which the first Vessel comes into service (Regulated Period).

KEY TERMS:

Regulated Ferry Route	Exclusivity - Licensee has the exclusive right to operate Ferry Services on the Regulated Ferry Route (Bukakata to Luku Point (Bugoma) to Bukakata) during the Regulated Period. No person can operate a competing service i.e. one which includes stops at both Bukakata and Luku Point (Bugoma) (via a direct or indirect route, and whether including two or more stops) and uses vessels over 20 meters or 40 metric tonnes. The existing Bukakata ferry (CDP 3503) will be withdrawn from service. Third parties may provide ferry services using new ferries on routes between the islands surrounding Bugala Island and Bukakata provided they (i) do not stop at Bugala Island and (ii) are provided comparable terms.
Unregulated Routes	<i>Non-exclusive</i> - Licensee can operate Ferry Services on a non-exclusive basis, on any of the following Unregulated Routes, provided it does not affect the Minimum Service Levels on the Regulated Ferry Routes: (a) any ferry route operating directly or indirectly between any of Bukakata, Luku Point (Bugoma), Bwendero or Mulabana Landing Sites or any other point on Bugala Island; and (b) any route between any location on the mainland to Bwendero where the Vessel has been privately chartered (with Minister's consent).
After Regulated Period	After the Regulated Period, no third person may be given an exclusive Licence to operate Ferry Services on the Regulated and the Unregulated Ferry Routes and the Licensee can continue to operate on those routes provided it meets minimum service levels.
Tariffs	During the Regulated Period, the Licence can set its own tariffs subject to pre-agreed minimum and maximum prices. These cannot be adjusted more than once in any 6-months period. Base prices used to calculate tariffs are set out below.
Construction	Vessels must be built to class and meet applicable maritime standards for construction and operation. TLB has the right of inspection.
Minimum Service Levels	The Licensee will provide Minimum Service Levels (see below) on the Regulated Ferry Routes which may only be interrupted or varied in limited circumstances.
Timetable	A 12 months timetable must be published in advance and the public notified of any changes thereto.
Assignment	With limited exceptions, the Licence is non-transferable.
Termination	If the Licensee fails to renew, relinquishes or breaches the Licence, it may be terminated.
Renewal	The Licensee may apply for renewal of the Licence on a non-exclusive basis.
Force Majeure	The Licensee is excused from performance where affected by circumstances beyond its reasonable control.

The Electoral Commission (Appointment of Date of Completion of the National Voters' Register General Update) Instrument, 2010.

(Under section 19(8)(a) of the Electoral Commission Act, Cap. 140)

IN EXERCISE of the powers conferred upon the Commission under section 19(8)(a) of the Electoral Commission Act, Cap. 140, this Instrument is made this 14th day of June, 2010.

1. Title.

This Instrument may be cited as the Electoral Commission (Appointment of Date for Completion of the National Voters' Register General Update) Instrument, 2010.

2. Appointment of date of completion.

The 18th day of June, 2010, is hereby appointed as the date upon which the Commission shall complete the exercise of updating the National Voters' Register for purposes of the General Election, 2011, except for the update exercise in Mukono County North Constituency, Mukono District.

3. Completion of update exercise in Mukono County North Constituency.

The 22nd day of June, 2010, is hereby appointed as the date upon which the Commission shall complete the exercise of updating the National Voters' Register for purposes of the General Election, 2011, in Mukono County North Constituency, Mukono District.

4. No application accepted after appointed date.

For the purposes of paragraph 2 and 3 of this Instrument, after the appointed dates, no application forms shall be accepted by the Electoral Commission, seeking—

- (a) to register as a voter; or
- (b) to transfer to a new voting location.
