APPLICATION FOR THE EXTENSION OF THE LICENCE OF AGGREKO-KIIRA POWER PLANT

The Electricity Regulatory Authority (ERA) has received an application from Aggreko International Power Projects Uganda for the extension of the Licence for the Electricity Generation and Sale under Section 44 of the Electricity Act 1999, Cap 145, and the Electricity (Application for Permit, Licence and Tariff Review) Regulations, 2007, SI 2007 No 60.

Aggreko International has applied for an extension of 12 months effective 1st July, 2010, with an option of a three months notice of termination after the first 6 months, should the GOU get an alternative source of energy before the end of the contract. The Licence conditions remain the same except that the Capacity price has been revised downwards from US\$38.2 per MW per hour to US\$35 per MW per hour.

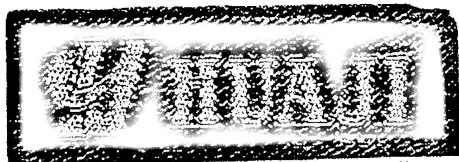
