





The Traffic and Road Safety (Driving Schools and Driving Instructors) Regulations, 2010

(Under sections 37, 38, 59 and 178(1) of the Traffic and Road Safety Act, Cap.361)

IN EXERCISE of the powers conferred upon the Minister responsible for transport by sections 59 and 178 (1) of the Traffic and Road Safety Act, 1998, these Regulations are made this 29th day of March, 2010.

PART I—PRELIMINARY

1. Title

These Regulations may be cited as the Traffic and Road Safety (Driving Schools and Driving Instructors) Regulations, 2010.

2. Interpretation

In these Regulations, unless the context otherwise requires—

- "Act" means the Traffic and Road Safety Act, 1998;
- "currency point" is equivalent to twenty thousand Uganda shillings;
- "driving instructor" means a person licensed to instruct another person to drive a motor vehicle;
- "driving school" means a school licensed under section 37 of the Act;
- "driving school instruction motor vehicle" means a motor vehicle used as a training vehicle for learner drivers;
- "learner driver" means a person to whom driving instruction is offered;
- "learner drivers training materials" means theory and practical materials for training learner drivers, approved by the Director of Transport and includes training manuals and teaching aids;

- "licence" means a licence issued in accordance with these Regulations;
- "licensing year" means the period of twelve months from the date of issue or renewal of a driving instructor's licence;
- "motor vehicle" means a self-propelled vehicle adapted or intended for use on the roads.

PART II—DRIVING SCHOOLS

3. Licence for driving school

- (1) A person who wishes to operate a driving school shall have a licence for the driving school issued by the Director of Transport.
- (2) A person who operates a driving school without a licence issued under the Act, commits an offence and is liable on conviction to a fine not exceeding twenty four currency points or imprisonment not exceeding one year or both.
- (3) The licence for a driving school shall be as prescribed in Form I in Schedule 1.

4. Conditions for licensing driving school

- (1) A driving school shall not be licensed by the Director of Transport except where the driving school—
 - (a) has licensed driving instructors for the group of motor vehicles in which driving instruction is to be offered;
 - (b) has a furnished classroom measuring at least ten square metres, or which is capable of comfortably accommodating a minimum number of ten students at any one time;
 - (c) has a minimum of two driving school instruction motor vehicles, other than group A motor vehicles, except where the school is to engage solely in training drivers of group A motor vehicles;
 - (d) has up-to-date copies of learner drivers training materials;

- (e) has an administration office furnished with the necessary facilities, as may be prescribed by the Director of Transport;
- (f) has an outdoor training ground measuring at least 50 x 100 metres, and clearly marked with driving lanes and soft cones;
- (g) has provisions that facilitate the training of learner drivers with disabilities and elderly people;
- (h) has a valid trading licence and a certificate of incorporation in respect of the driving school;
- (i) complies with the Act and these Regulations; and
- (j) satisfies any other requirements as may be prescribed by the Director of Transport.
- (2) An owner of a driving school shall allow the Director of Transport to inspect the premises of the driving school and to examine the equipment and material to be used in the operation of the driving school
- (3) Where a driving school has branches, each branch shall be assessed independently and shall comply with the provisions of these Regulations.

5. Application for licence

- (1) A person who wishes to operate a driving school shall apply to the Director of Transport for a licence, using Form II in Schedule 1.
- (2) An applicant for a licence shall furnish the Director of Transport with information in respect of the driving school, as may be required by the Director of Transport.
- (3) An application for a licence for a driving school shall be accompanied by a fee as prescribed in Schedule 2.

6. Validity of licence

(1) A licence for a driving school shall be valid for a period of twelve months from the date of issue.

(2) A licence issued under subregulation (1) may be renewed.

7. Display of licence

- (1) A licence to operate a driving school shall be displayed in a conspicuous place at the premises of the driving school and shall be produced for inspection at the request of the Director of Transport or a police officer.
- (2) A person who contravenes this regulation commits an offence and is liable on conviction to a fine not exceeding ten currency points or imprisonment not exceeding five months or both.

8. Revocation of licence

- (1) The Director of Transport may revoke a licence issued under these Regulations where it is proved or if he or she is satisfied, that the owner of the driving school—
 - (a) carried on the business of a driving school in an improper or unsatisfactory manner;
 - (b) failed to comply with these Regulations or any of the conditions upon which the driving school licence is issued; or
 - (c) improperly obtained the licence, contrary to these Regulations or to any other conditions of the licence, or using false information
- (2) Before a driving school licence is revoked under this regulation, the Director of Transport shall in writing, notify the owner of the affected driving school of the intention to revoke the licence.
- (3) The notification in subregulation (2) shall clearly specify the reasons for the revocation of the licence and the date at which the revocation is to be made effective.
- (4) An owner of a driving school who is given notification of revocation shall be given a chance to shows cause why the licence should not be revoked.

- (5) Where a licence is revoked, the Director of Transport shall specify to the owner of the driving school the period after which he or she may re-apply for a new licence and the conditions to be fulfilled before the new licence is issued.
- (6) A person who alters the particulars of a driving school whose licence is revoked under this regulation, commits an offence and is liable on conviction to a fine not exceeding thirty currency points or imprisonment not exceeding fifteen months or both.

9. Inspection of premises, equipment and learner drivers training materials of driving school

The Director of Transport shall from at any time, during working hours, inspect the premises of a driving school and the equipment and learner drivers training materials used for instruction in the driving school, to ensure compliance with these Regulations and with the conditions of the licence issued to the driving school.

10. Driving school instruction motor vehicle

- (1) Every driving school instruction motor vehicle shall be in good mechanical condition.
 - (2) A driving school instruction motor vehicle shall be—
 - (a) clearly marked with the name of the driving school on both sides of the motor vehicle; and
 - (b) fitted with an "L" identification plate at the front and at the rear of the motor vehicle.

11. Certificate of fitness

- (1) Each instruction motor vehicle shall every twelve months, on payment of the fee prescribed in Schedule 2 be issued with a certificate of fitness.
- (2) For the purposes of issuing a certificate of fitness, a driving school instruction motor vehicle shall be inspected annually by the inspector of vehicles to confirm that the instruction motor vehicle—

- (a) is in a good mechanical condition;
- (b) except for a group A motor vehicle, is fitted with dual brakes and dual clutches, where the motor vehicle is for manual transmission, and with dual brakes, where the motor vehicle is for automatic transmission;
- (c) is fitted with a clearly visible rooftop sign whose material and background is retro-reflective and which shall be in the form prescribed in Schedule 3, except groups A, F, H and I motor vehicles which may be exempted from this requirement where it is not practically possible to affix the signage;
- (d) is fitted with "L" identification plates; and
- (e) is insured against third party risks and has such insurance policies as may be prescribed by the Director of Transport.
- (3) The certificate of fitness may be renewed.
- (4) The certificate of fitness shall not be transferable.
- (5) The certificate of fitness shall be displayed at a conspicuous place on the motor vehicle in which driving instruction is offered.
- (6) Where the Director of Transport determines that a driving school instruction motor vehicle is not in a mechanical condition required for the purposes of being used as such, the Director of Transport may, without giving notice, revoke the certificate of fitness of the driving school instruction motor vehicle.
- (7) The certificate of fitness shall be as prescribed in Form III in Schedule 1.
- (8) Where a driving school instruction motor vehicle is used contrary to this regulation, the owner of the driving school commits an offence and is liable on conviction to a fine not exceeding ten currency points or imprisonment not exceeding five months or both.

12. Records

- (1) Every driving school shall keep records comprising—
- (a) the particulars of the driving school motor vehicles;
- (b) the particulars of the students enrolled at the driving school; and
- (c) any other information relevant to the training of learner drivers as may be prescribed by the Director of Transport.
- (2) The records of a driving school shall be kept in such a form as shall be prescribed by the Director of Transport.
- (3) Every driving school shall, every three months submit to the Director of Transport a list of learner drivers that undertake and successfully complete the learner driver training course.
- (4) The Director of Transport may at any time inspect the records of a driving school.
- (5) An owner of a driving school who contravenes this regulation commits an offence and is liable on conviction to a fine not exceeding twenty currency points or imprisonment not exceeding ten months or both.

PART III—TRAINING COURSES FOR LEARNER DRIVERS AND DRIVING INSTRUCTORS

13. Training course for learner drivers

- (1) The training course for learner drivers shall be conducted by a licensed instructor using learner driver training materials.
- (2) Where an instructor or a driving school wishes to use additional training materials, the materials shall, prior to being used for instruction, be approved by the Director of Transport.

- (3) The training course shall comprise both theory and practical lessons.
- (4) The theory and practical training lessons shall cover every aspect of driving as prescribed in the learner driver training materials.
- (5) The theory lessons shall be conducted in an approved classroom and the practical lessons shall be conducted within an approved training ground and on the road, in accordance with the guidelines prescribed in the learner driver training materials.
- (6) A person who contravenes this regulation commits an offence and is liable on conviction to a fine not exceeding ten currency points or imprisonment not exceeding five months or both.

14. Duration of training course for learner drivers

- (1) The training course shall comprise theory lessons conducted for an effective period of at least thirty hours and practical lessons conducted for an effective period of at least sixty hours.
- (2) A driving school that offers driving lessons to a learner driver shall on completion of the training, issue a certificate of completion of a driver training course to the learner driver.
- (3) The certificate of completion of a driver training course shall be as prescribed in Form IV in Schedule 1.

15. Approval of training for driving instructors

- (1) An institution that wishes to conduct training for driving instructors or training in driving refresher courses such as defensive driving shall make an application in writing to the Director of Transport requesting for approval to conduct that training course.
- (2) The Director of Transport shall determine the criteria for authorising institutions to conduct driving refresher courses and instructors' driving courses.
- (3) The Director of Transport shall upon receipt of the application in subregulation (1) assess the application on the basis of the conditions that shall be prescribed under sub-regulation (2) of this regulation.

(4) The Director of Transport shall issue a training approval certificate to an institution that fulfills the conditions in subregulation (2) and upon payment of a fee prescribed in Schedule 2.

16. Validity and form of training approval certificate

- (1) A training approval certificate shall be valid for a period of twelve months from the date of issue and shall be subject to renewal.
- (2) The training approval certificate shall be as prescribed in Form V in Schedule 1.

17. Suspension or revocation of training approval certificate

- (1) The training approval certificate shall be issued with conditions, and where an institution fails to comply with the conditions on which the certificate is issued, the certificate shall be automatically suspended or revoked.
- (2) The Director of Transport shall, before suspending or revoking a training approval certificate, notify the institution concerned, of the intention to do so.
 - (3) The Director of Transport shall in the notification—
 - (a) give a notice of fourteen days from the date of the notification, upon which the suspension or revocation is to be effected; and
 - (b) request the institution to show cause why the training approval certificate should not be suspended or revoked.
- (4) An institution that gets a notification under this regulation may before the expiry of the period given under subregulation (3) (a), appeal, in writing, to the Minister, against the decision to suspend or revoke the certificate.
- (5) An order to suspend or revoke a training approval certificate shall not take effect until expiry of the period specified in subregulation (3) (a).

- (6) An institution whose training approval certificate is suspended or revoked in accordance with this regulation, shall from the date the suspension or revocation becomes effective, cease to give training for driving instructors or training in driving refresher courses.
- (7) The Director of Transport shall notify the public of a suspension or revocation of an institution's training approval certificate, by notice—
 - (a) published in at least two newspapers with national coverage; or
 - (b) aired on at least two radio stations with national coverage.
- (8) An institution whose training approval certificate is suspended or revoked shall immediately surrender the certificate to the Director of Transport.
- (9) Where an institution's training approval certificate is suspended, the Director of Transport shall determine the period of suspension and shall inform the institution, in writing, of the duration of suspension of the certificate.
- (10) Where an institution's training approval certificate is revoked, the Director of Transport may at any time lift the revocation order where the Director of Transport is satisfied that the institution has rectified the circumstances that led to the revocation of the certificate.
- (11) Where a revocation is lifted, the institution whose certificate was revoked may make a fresh application for a new training approval certificate, in accordance with these Regulations.

PART IV—DRIVING INSTRUCTORS' LICENCE

18. Licence for driving instructor

- (1) A person who wishes to instruct a learner driver to drive any group of motor vehicles and who fulfills the requirements of regulations 19 and 20, shall be issued with a driving instructor's license.
- (2) A driving instructor's licence may be issued in respect of one group of motor vehicle or more groups of motor vehicles in which the driving instructor is so qualified.

- (3) The Director of Transport shall issue a driving instructor's licence, with or without conditions and where the driving instructor's licence is subject to conditions, the driving instructor to whom the licence is issued shall comply with the conditions.
- (4) The driving instructor's licence shall be valid for a period of twelve months.
- (5) The driving instructor's licence shall be as prescribed in Form VI in Schedule 1.
- (6) A person who instructs another person to drive a motor vehicle without a driving instructor's licence commits an offence and is liable on conviction to a fine not exceeding twenty currency points or imprisonment not exceeding ten months or both.

19. Conditions for issuing driving instructor's licence

- (1) A person who wishes to be issued with a driving instructor's licence shall—
 - (a) not be less than twenty four years of age and not more than sixty five years, however, the Director of Transport may licence a driving instructor who is more than sixty five years to continue offering driving instruction where that person is proved to be fit to do so;
 - (b) have had a driving permit for at least five years, for the group of motor vehicles he or she intends to instruct learner drivers to drive;
 - (c) have a minimum qualification of the Uganda Certificate of Education or its equivalent;
 - (d) be able to write, read and communicate effectively in the English language;
 - (e) have undertaken and successfully completed a driving instructors' course from an institution approved by the Director of Transport;

- (f) subject to regulation 20 (3), have passed the driving instructors' tests and examinations;
- (g) be in good physical and mental health.
- (2) A person who is issued with a driving instructor's licence shall pay the fee for the category of licence as prescribed in Schedule 2.

20. Application for driving instructor's licence

- (1) A person who wishes to be issued with a driving instructor's licence, may apply to the Director of Transport using Form VII in Schedule 1.
- (2) The application form shall be accompanied by documents indicating the driving qualifications of the applicant issued by a driving instructor training institute approved by the Director of Transport and a certified medical report from a registered medical practitioner ascertaining that the applicant is in good physical and mental health.
- (3) The Director of Transport may require the applicant, prior to being licensed under these Regulations, to undergo tests and examinations for the purpose of ascertaining that he or she has the necessary competencies to give driving instruction to learner drivers.
- (4) A person who obtains a driving instructor's licence by false pretence commits an offence and is liable on conviction to a fine not exceeding thirty currency points or imprisonment not exceeding fifteen months or both.

21. Refusal to issue driving instructor's licence

The Director of Transport shall not issue a driving instructor's license to a person—

- (a) who fails the instructors' driving test;
- (b) who in the opinion of the Director of Transport does not possess driving skills, sufficient to instruct in the operation of motor vehicles;

- (c) who by reason of mental or physical disability is incapable of competently instructing in the operation of motor vehicles;
- (d) who is prohibited from driving a motor vehicle under the Act;
- (e) who is convicted of more than two major traffic offences in the preceding two years;
- (f) whose conduct and disposition is against the requirements prescribed by these Regulations and the conditions for issuing a driving instructor's license.

22. Code of conduct for driving instructors

- (1) A driving instructor shall not instruct a learner driver unless he or she possesses a valid instructor's licence corresponding to the group of motor vehicle the learner driver is being instructed in.
- (2) A driving instructor shall not use an instruction motor vehicle unless the motor vehicle has a valid certificate of fitness issued under regulation 11.
- (3) A driving instructor shall not instruct a learner driver who does not possess a valid learner's driving permit.
- (4) A driving instructor shall not instruct a learner driver while the driving instructor is under the influence of alcohol or drugs, or is consuming alcohol or drugs.
- (5) A driving instructor shall not instruct a learner driver who is under the influence of alcohol or drugs or who is consuming alcohol or drugs at the time of instruction.
- (6) A driving instructor shall not at any time allow a learner driver to use an instruction motor vehicle on the road without him or her having full or partial control of the vehicle.
- (7) The driving instructor may permit a learner driver to drive a motor vehicle without him or her being present in the vehicle at the time, where the driving lesson is conducted in an open ground and where the driving instructor is within a distance of not more than ten meters from the motor vehicle.

(8) A driving instructor who contravenes this regulation commits an offence and is liable on conviction to a fine not exceeding ten currency points or imprisonment not exceeding five months or both.

23. Supervision and monitoring of driving instructors

- (1) To ensure compliance with these Regulations, the Director of Transport shall supervise and monitor the driving instructors.
- (2) Supervision and monitoring under this regulation shall include—
 - (a) assessing the manner in which driving instructions are given to learner drivers in respect of the theory and the practical driving lessons;
 - (b) ascertaining that the established standards are followed by all driving instructors and that the learner drivers are trained in accordance with the learner drivers training materials.

24. Renewal of driving instructor's licence

- (1) A driving instructor's licence may be renewed.
- (2) Before renewing a driving instructor's licence, the Director of Transport may require the driving instructor to—
 - (a) take additional tests and examinations relevant to the group of motor vehicles the driving instructor instructs learner drivers to drive;
 - (b) take a medical examination to ascertain the condition of his or her physical and mental health, particularly the condition of his or her vision; and
 - (c) provide proof that the driving instructor undertook at least one driving instructors' refresher course as required under regulation 27.
- (3) The fee for the renewal of a driving instructor's licence shall be the same as the fee for application for a driving instructor's licence.

25. Proof of possession of driving instructor's licence

- (1) A driving instructor shall upon request by a police officer or the Director of Transport, immediately, produce the original copy of his or her driving instructor's licence.
- (2) A driving instructor who, without reasonable cause, does not comply with subregulation (1) commits an offence and is liable on conviction to a fine not exceeding ten currency points or imprisonment not exceeding five months or both.

26. Training for driving instructors

- (1) A driving instructor shall undergo training in a training institution approved by the Director of Transport.
- (2) A driving instructor shall be trained using driving instructors training materials approved by the Director of Transport.
- (3) A driving instructor may also undergo training outside Uganda in a recognised training institution, in which case, the driving instructor shall submit to the Director of Transport for certification, the qualifications obtained.
- (4) An institution that trains a driving instructor, shall upon completion of training course, issue the driving instructor with a certificate of completion of training, prescribed in Form VIII in Schedule 1.

27. Refresher courses for driving instructors

- (1) During a licensing year, a driving instructor shall for the purpose of enhancing his or her driving instruction skills, undertake at least one driving instructors' refresher course for the group of motor vehicles he or she instructs learner drivers to drive.
- (2) In addition to the requirements of subregulation (1), a driving instructor for a public service vehicle and a driving instructor for a medium or a heavy commercial vehicle shall, during the licensing year, undertake at least one refresher course in defensive driving.
- (3) The refresher courses for driving instructors shall be offered by institutions approved by the Director of Transport.

(4) A refresher course offered outside Uganda shall be subject to verification by the Director of Transport.

28. "L" Plates

- (1) The Director of Transport shall, upon payment of the fee prescribed in Schedule 2, issue a driving instructor with a set of "L" identification plates for the motor vehicle to be used by the driving instructor for the purpose of offering driving instructions.
- (2) Where an "L" plate is lost, the Director of Transport shall issue a replacement plate for the same fee as the fee prescribed in subregulation (1).
- (3) A driving instructor who uses a motor vehicle to train a learner driver without the "L" identification plates being affixed to the motor vehicle, commits an offence and is liable on conviction to a fine not exceeding twenty currency points or imprisonment not exceeding ten months or both.

29. Suspension or revocation of driving instructor's licence

- (1) The Director of Transport may suspend or revoke a driving instructor's licence where the Director of Transport considers it necessary in the interest of public safety to do so or where he or she is satisfied that the driving instructor—
 - (a) obtained the licence by false pretense;
 - (b) is no longer fit or competent to continue to hold a driving instructor's licence by reason of his or her conduct or of a physical disability;
 - (c) is contravening or has contravened any of these Regulations or the conditions of the driving instructor's licence.
- (2) The Director of Transport shall, before suspending or revoking a driving instructor's licence, notify the driving instructor concerned, of the intention to do so.

- (3) The Director of Transport shall in the notification—
- (a) give a notice of fourteen days from the date of the notification, upon which the suspension or
- (b) revocation is to be effected; and
- (c) request the driving instructor to show cause why the driving instructor's licence should not be suspended or revoked.
- (4) A driving instructor who gets a notification under this regulation may before the expiry of the period given under subregulation (3) (a), appeal, in writing, to the Minister, against the decision to suspend or revoke his or her driving instructor's licence.
- (5) An order to suspend or revoke a driving instructor's licence shall not take effect until expiry of the period specified in subregulation (3) (a).
- (6) A driving instructor whose driving instructor's licence is suspended or revoked in accordance with this regulation, shall from the date the suspension or revocation becomes effective, cease to give driving instructions to any person.
- (7) The Director of Transport shall notify the public of a suspension or revocation of a driving instructor's licence, by notice—
 - (a) published in at least two newspapers with national coverage; or
 - (b) aired on at least two radio stations with national coverage.
- (8) A driving instructor whose licence is suspended or revoked shall immediately surrender it to the Director of Transport.
- (9) Where a driving instructor's license is suspended, the Director of Transport shall determine the period of suspension and shall inform the driving instructor, in writing, of the duration of suspension of the licence.

- (10) Upon the expiry of the period of suspension, the driving instructor's licence shall be effective except where the licence has expired, in which case it shall be subject to renewal.
- (11) Where a driving instructor's license is revoked, the Director of Transport may at any time lift the revocation order where the Director of Transport is satisfied that the driving instructor has rectified the circumstances that led to the revocation of the licence.
- (12) Where a revocation is lifted, the driving instructor whose licence was revoked may make a fresh application for a new driving instructor's licence, in accordance with these Regulations.

PART V—MISCELLANEOUS

30. Register of driving schools and driving instructors

- (1) The Director of Transport shall maintain a register of driving schools and driving instructors.
- (2) The Director of Transport shall every six months, using appropriate means of communication, notify the public of the licensed driving schools and driving instructors.

31. Duplicate licences

- (1) Where a licence issued under these Regulations is misplaced or lost, the Director of Transport shall upon presentation of proof of ownership of the misplaced or lost licence and a police report confirming the loss or misplacement, issue a duplicate licence.
- (2) The fee for a duplicate licence shall be equivalent to fifty percent of the fees paid for the original licence.
- (3) The expiry date of a duplicate licence shall be the date of expiry of the original licence.



- 3. The roof top sign shall be made in such a way that it illuminates in the dark.
- 4. The words "DRIVER UNDER INSTRUCTION" shall be in black and 4cm in height.
