*(Under section 135 of the Traffic and Road Safety Act, Cap. 361).*

IN EXERCISE of the powers conferred upon the Minister responsible for transport by section 135 and 175 of the Traffic and Road Safety Act, Cap. 361 this Order is made this 28th day of July, 2010.

**1. Title.**

This Order may be cited as the Traffic and Road Safety (Speed of Motor Vehicle) (Exemption) (No. 7) Order, 2010.

**2. Exemption.**

(1) A person who drives a motor vehicle and who competes in the UMOPOC Challenge Rally, organised by the Federation of Motor Sports Club of Uganda (FMU) in conjunction with United Motorsports Club scheduled to take place on the 7th - 8th August, 2010 in Mukono District is exempted from the provisions of section 120 of the Traffic and Road Safety Act, Cap. 361, for the duration of that rally.

(2) A person exempted under sub paragraph (1) shall not exceed a maximum speed of 180 km per hour.
