NOTICE OF INTENDED APPLICATION FOR A LICENCE FOR GENERATION AND SALE OF ELECTRICITY

The Electricity Regulatory Authority (ERA) has under Section 29 of the Electricity Act 1999, Cap 145, received a Notice of Intended Application for a Licence from Albatross Energy (U) Limited.

Albatross Energy (U) Limited intends to Build, Own and Operate a 230MW heavy fuel oil (HFO) plant for generation and sale of electricity in Tororo District. The power generated is for sale to the National Grid. Due to the need to upgrade the existing transmission system between Tororo and Kampala in order to transfer this amount of power, Albatross Energy (U) Limited has subsequently proposed to implement the project in two phases starting with 100MW, and then add on 130MW when the transmission system is upgraded.
