The Traffic And Road Safety (City Bus Services) Regulations, 2011.

(Under sections 71 and 178 of the Traffic and Road Safety Act, Cap. 361)

IN EXERCISE of the powers conferred upon the Minister responsible for transport by sections 71 and 178 of the Traffic and Road Safety Act, 1998, these Regulations are made this 10th day of December, 2010.

PART I—PRELIMINARY

1. Title.

These Regulations may be cited as the Traffic and Road Safety (City Bus Services) Regulations, 2011.

2. Interpretation.

In these Regulations, unless the context otherwise requires—

“Act” refers to the Traffic and Road Safety Act, 1998;

“agent” means a person duly appointed by the Council under regulation 4;

“authorised person” means a person who has permission to perform a particular act;

“Board” means the Transport Licensing Board;

“bus” means a motor vehicle designed for carrying a minimum of sixty(60) passengers, with an entry and exit point and used for the transportation of persons in a commercial seating arrangement for compensation other than a motor vehicle or automobile for hire, funeral car or taxi cab used in a ridesharing arrangement;

“bus driver” means a person who holds a valid driving license granted under the Act and drives or is in actual physical control of a bus;

“bus lane” means a traffic lane intended for bus use only;

“bus routes” means the routes designated to be followed by a bus;

“bus stop” means a place on a bus route where buses stop to discharge and take on passengers;

“bus terminal” means a designated area or building other than a bus stop, where buses converge to allow passengers board or leave the bus;

“bus travel ticket” means a small piece of paper or card issued by or on behalf of an operator of a bus service for the purpose of authorising a person to travel in a particular bus operated in the service;

“currency point” is equivalent to twenty thousand Shillings;

“concession ticket” means a ticket issued free or at a reduced fare by an operator of a bus service or his or her agent;

“Council” means the City Council of Kampala;

“equipment” includes but shall not be limited to particulars specified in regulation 10;

“operator” means a person contracted by the Council to provide city bus services;

“ridesharing arrangement” means participants travelling together in carpools, vanpools or buspools for example a family with children or friends.

3. Application.

These Regulations shall apply to Kampala and the surrounding districts of Wakiso and Mukono.

PART II—BUS SERVICES

4. Bus routes, lanes and stops.

(1) The Council shall, in consultation with the Minister, designate roads, routes, stops and lanes for bus use.

(2) The Council shall, by notice in the gazette publish the names of roads, routes, stops and lanes identified under sub regulation (1).

5. Control of bus lanes, stops and routes.

The Council shall be responsible for the control and management of bus roads, routes, stops and lanes designated under these Regulations.

6. Appointment of an agent.

The Council may appoint an agent to carry out its functions conferred upon the Council under these Regulations.

7. Bus Capacity.

(1) The bus capacity of every bus shall be determined by the Board.

(2) An operator of a bus shall not carry a greater number of passengers than the number determined by the Board in subregulation (1).

8. Bus colour and logo.

(1) Every bus operator shall register with council a logo and colour of their choice to be painted on their bus for purposes of easier identification.

(2) The colour and logo registered in accordance with subregulation (1) shall not be used by any bus operator other than a bus operator under these Regulations.

PART III—OPERATION OF BUS SERVICES

9. Equipment and condition of buses.

(1) Subject to these Regulations, every bus shall, in addition to other equipment required under the Act, be equipped with—

- (a) a fire extinguisher of a design and type approved by Council;
- (b) not less than two non-skid type tire chains suitable in size for the tires of the vehicle;
- (c) a hazard warning kit;

- (d) a first aid kit, with printed instructions as to the use of its contents, consisting of either a pillow type case or metal case containing not less than—
 - (i) four packets containing four (4) hand cleansers and twelve (12) gauze cleansing pads each;
 - (ii) one hundred and fifty (150) adhesive dressings 2.5 centimetres by 7.5 centimetres individually wrapped;
 - (iii) eight (8) compress dressings, 5 centimetres;
 - (iv) six (6) compress dressings, 10 centimetres;
 - (v) two (2) eye dressing kits; one (1) eye shield and two (2) gauze pads;
 - (vi) three (3) gauze dressings, four (4) ply, minimum 90 centimetres by 90 centimetres;
 - (vii) two (2) gauze bandages, 5 centimetres by 5.5 centimetres;
 - (viii) one adhesive tape 2.5 centimetres by 4.5 metres;
 - (ix) six (6) triangular bandages;
 - (x) one metal splint, 7 centimetres by 60 centimetres;
 - (xi) one pair of scissors;
 - (xii) one pair of sliver tweezers; and
 - (xiii) twelve (12) safety pins, 5 centimetres;
- (e) a mirror which shall provide the bus driver with a view of the passengers;
- (f) a mirror securely attached to the bus and placed in a position so as to afford the bus driver an unobstructed view of the roadway immediately in front of the bus;
- (g) push-out emergency windows or an escape door which shall be located at the rear or rear left side of the body of the bus and shall be equipped with a fastening device which provides for quick release but ensured against accidental opening.

(2) All equipment referred to in subsection (1) shall at all times be kept in good operative condition.

(3) A person who—

(a) tampers with, damages, destroys or removes from a bus other than for its proper use the equipment referred to in subsection (1); or

(b) other than an operator, his or her agent, employee or inspector, except in an emergency, opens an escape door, commits an offence and is liable on conviction to a fine not exceeding twenty currency points or imprisonment not exceeding one year or both.

10. Maintenance and ventilation.

An operator of a bus shall at all times ensure that the bus is maintained in a clean and sanitary condition and is adequately ventilated.

11. Timetables.

(1) An operator of a bus service shall draw up a timetable for the bus service and shall ensure that the timetable can reasonably be met without any need for buses to break any relevant speed limits.

(2) The operator of a bus service shall, on request by the Council, provide a copy of the timetable in subregulation (1).

(3) Any bus that has to be removed from the timetable for whatever reason, shall be immediately replaced with another bus.

12. Valid driving permit.

An operator of a bus service shall not permit a person to drive a bus unless he or she is satisfied that the person is a holder of a valid driving permit issued under the Act.

13. Information in buses

(1) An operator of a bus service shall ensure that necessary information is displayed in a conspicuous position inside the bus in accordance with subregulation (2).

(2) The following information shall be displayed inside the bus—

- (a) a summary of the rights and obligations of the passengers;
- (b) brief details on how and where complaints relating to the bus service may be made; and
- (c) telephone contact of the management of the bus service.

(3) A bus driver shall announce the name of the next bus stop at least one hundred metres (100m) before reaching that bus stop.

14. Destination and signs on buses.

A bus driver shall not operate a bus service unless at all times while the bus is being used for that service, a destination sign and route number are clearly displayed on the front of the bus and can be illuminated.

15. Working hours.

(1) The bus service shall be a twenty four (24) hour service.

(2) A bus driver shall not operate a bus for more than eight hours in one shift.

16. Conveyance of passengers.

(1) A bus driver shall—

- (a) stop the bus and drop off a passenger at the nearest bus stop if the passenger indicates to the bus driver that he or she wishes to get off the bus;
- (b) stop the bus and pick up a person at a bus stop if the person indicates to the bus driver that he or she wishes to get on the bus.

(2) A bus driver shall when disembarking a passenger, park parallel to and as close as practicable to the side of the road of the bus stop.

(3) A bus driver shall only stop the bus at designated bus stops and stages on the route.

17. Over loading.

(1) A bus driver shall not carry in a single-decked bus or on either deck of a two-decked bus a greater number of passengers than the number authorised to be carried.

(2) When calculating the number of passengers, a child under the age of five years held by a passenger, shall not be taken into account.

(3) An operator of a bus shall display in a conspicuous position on the outside of the rear of the bus and in letters of at least twenty five millimeters high and of proportionate breadth, the number of passengers authorised to be carried on the bus.

18. Limited bus stops

A bus driver shall not pick or drop a passenger at any place other than a place designated as a bus stop.

19. Carriage of goods

(1) Goods or luggage shall not be carried on a bus in a position that is likely to obstruct the bus driver or inconvenience other passengers on the bus.

(2) The interior and exterior of every bus shall be free of all unnecessary articles which are likely to injure passengers.

(3) A passenger's luggage shall be properly secured on a bus, in a manner that separates the luggage from the passenger compartment or in a way that it cannot easily come in contact with passengers in case of an accident.

(4) For the purpose of this section, luggage includes travelling bags and personal belongings of passengers but excludes small hand held baggage that is normally carried by or with the passenger.

20. Restricted areas on the bus

(1) A bus driver shall not allow a passenger—

- (a) to enter the bus driver's compartment;
- (b) to occupy the bus driver's seat or a part of the bus driver's seat;
- (c) on a part of the bus not designed to carry passengers;
- (d) on a part of the bus beside or in front of the bus driver's seat; or
- (e) if the bus is a double-decker to stand on the upper deck of the bus.

(2) Without prejudice to sub regulation (1), the parts of the bus not designed to carry passengers include—

- (a) the roof, steps and footboard; and
- (b) if the bus is a double-decker the stairs to the upper deck,

21. Bus entrance and exit

Every entrance and exit of a bus shall be kept clear of obstruction while passengers are being carried and for purposes of this section passengers permitted by these Regulations to stand, shall not be considered to constitute an obstruction.

22. Conduct of bus driver and members of the bus crew.

(1) A bus driver shall not—

- (a) smoke while driving;
- (b) solicit for passengers;
- (c) collect fares while the bus is in motion;
- (d) move the bus before the doors are closed; or
- (e) negligently or willfully start or cause the bus to be started in a way that subjects a passenger or intending passenger to unnecessary risk of injury.

(2) An operator of a bus service shall ensure that the entire bus crew abides by the code of conduct as agreed between the operator and the Council.

PART IV—TICKETS

23. Bus driver to remain at the bus driver's seat.

A bus driver shall not, without reasonable cause, vacate, abandon or leave his or her seat until he or she reaches the designated bus terminal.

24. Travel fares.

(1) Bus fares shall be determined in accordance with the distance traveled on the bus.

(2) Every person who boards a bus shall pay a travel fee as prescribed by the Council.

25. Issuance of tickets.

An agent shall issue a travel ticket to a passenger who is desirous, intends or boards a bus at any time and that person shall pay for the fare in any of the following ways—

- (a) single journey;
- (b) return journey;
- (c) daily zone ticket;
- (d) weekly zone ticket;
- (e) monthly zone ticket.

26. Validity of tickets.

(1) A person shall not be allowed to travel on a bus without a valid travel ticket.

(2) A ticket is valid for travel only for the route or routes for which it is issued.

27. Alteration or defacing tickets prohibited.

A person shall not, with intent to deceive, change or deface a ticket or make a ticket illegible or for a ticket with a magnetic strip, make that ticket inoperative.

28. Concession tickets

(1) A person shall not travel in a bus using a concession ticket unless the person is entitled to use that ticket.

(2) A bus driver, police officer or authorised person may require a person with a concession ticket to produce satisfactory evidence that he or she is entitled to use that ticket to travel on the bus.

(3) A person shall not, without reasonable excuse, fail to comply with sub regulation (2).

(4) A person shall not in relation to an application for a concession ticket or in purported compliance with a requirement under sub regulation (2)—

- (a) state any thing that he or she knows to be false or misleading in a material particular;
- (b) omit from a statement anything without which the statement is, to the person's knowledge, misleading in a material particular;

PART V—INSPECTION AND PROCESSING OF TICKETS

29. Inspection of tickets

Every passenger on a bus shall make his or her ticket available for inspection or processing by an authorised person.

30. Tickets to be offered for processing

(1) A person shall not, without reasonable excuse, get on a bus without offering his or her ticket for processing in accordance with this regulation.

(2) A person offers a ticket for processing—

- (a) by putting it into automatic equipment provided to read or record any details on the ticket; or
- (b) by showing the ticket to the bus driver or authorised person.

(3) A person shall offer his or her ticket for processing as mentioned in sub regulation (2) (a) unless—

- (a) the person's ticket is not designed for insertion in automatic equipment;
- (b) the bus is not supplied with automatic equipment; or
- (c) the person has a reasonable excuse for not using the automatic equipment.

PART VI—CONDUCT OF PASSENGERS

31. General conduct

(1) A person shall not unreasonably interfere with the comfort or safety of anyone on the bus.

(2) Without prejudice to sub regulation (1), a person unreasonably interferes with the comfort or safety of another person when he or she—

- (a) puts a foot on a seat;
- (b) spits;
- (c) uses offensive language;
- (d) behaves offensively; or
- (e) uses a wheeled recreational device.

32. Drinking of liquor prohibited

A person shall not consume liquor while on the bus.

33. Smoking, eating and drinking

- (1) A passenger shall not smoke on the bus.

(2) A passenger shall not eat or drink in a part of the bus where eating and drinking is prohibited by signs displayed in the bus except with permission from the bus operator.

(3) Nothing in this regulation prohibits a passenger from drinking or eating for medical reasons.

34. Unauthorised commercial activities.

(1) A passenger shall not carry on any commercial activity in the bus.

(2) For purposes of this regulation "commercial activity" means any of the following—

- (a) sale of any item;
- (b) touting or soliciting for custom, hire or employment;
- (c) distribution of handbills; and
- (d) soliciting of money from passenger.

35. Entry to and exit from bus

A bus driver of a bus shall not permit passengers to embark or disembark while the bus is in motion.

PART VII—MISCELLANEOUS.

36. Seats for the elderly and people with disabilities

(1) A bus operator may, by notices on the bus, set aside seats for older people or people with a disability and specify the people who may use the seats.

(2) Where a seat on a bus is set aside for particular people under sub regulation (1), a person for whom the seat is not set aside must not continue to occupy the seat if a person for whom the seat is set aside is standing.

37. Littering and throwing of objects

(1) A person shall not throw anything in or from a bus.

(2) A person shall not litter or dispose of any thing that may endanger other passengers or property on the bus, except in places or containers specifically provided for that purpose.

38. Animals

(1) A person shall not be allowed to travel with any animal except with the bus driver's permission.

(2) Sub regulation (1) shall not apply to—

- (a) an animal accompanying a person with a disability that is trained to help that person alleviate the effect of the disability;
- (b) an animal that is being trained to help alleviate the effect of disability.

39. Soiled luggage and clothing

(1) A bus driver, police officer or authorised person may refuse a passenger to get on the bus if the bus driver or authorised person reasonably believes that the person's clothing or luggage may soil or damage the bus or the clothing or goods of other passengers.

(2) A bus driver or authorised person may refuse a passenger to get on the bus or order him or her to get off the bus if the bus driver or authorised person reasonably believes that the size of the passenger's luggage cannot be accommodated in the bus without inconvenience to other passengers.

(3) Where a passenger is refused to get onto the bus or is ordered to get off the bus, his or her bus fare shall be refunded.

40. Intoxicated bus drivers

(1) A bus driver shall not drive under the influence of alcohol.

(2) A bus driver who contravenes sub regulation (1) commits an offence and is liable on conviction to a fine not exceeding thirty currency points or imprisonment not exceeding twelve months or both.

41. Intoxicated passengers

(1) Where in the opinion of a bus driver or an authorised officer, a passenger or an intending passenger—

(a) is under the influence of alcohol or any drug; and

(b) causes, or is likely to cause, a nuisance or annoyance to other passengers,

the bus driver or authorised officer may direct that person to leave or not to enter the bus.

42. Power to remove a passenger

(1) A bus driver, police officer or authorised person may direct a person to get off the bus if the bus driver, police officer or authorised person reasonably believes that the person has committed an offence under these Regulations.

(2) A person who fails, refuses, ignores or neglects to comply with a direction under sub regulation (1) shall be removed from the bus using reasonable force.

43. Interference with or damage to bus equipment

(1) A passenger shall not without reasonable excuse—

- (a) interfere with any equipment attached to or forming part of the bus;
- (b) block the bus door;
- (c) open a locked bus door while the bus is in motion; or
- (e) interfere with an automatically operated bus door.

(2) Subregulation (1) does not apply to an authorised officer in the execution of his or her duty.

44. Bus driver to take action in relation to dangerous conduct

(1) A bus driver shall take appropriate action if he or she believes on reasonable grounds that the conduct of a passenger is endangering the safety of other passengers.

(2) For purposes of subregulation (1) appropriate action may include—

- (a) calling the police for help; and
- (b) contacting the operator of the bus for assistance.

45. Lost property.

An operator of a bus service shall develop procedures for dealing with any unidentified articles found on the bus and these procedures may include—

- (a) keeping registers of articles found or handed in by passengers;
- (b) keeping written records of when and how articles found or handed to the responsible people are returned or disposed of.

PART VIII—OFFENCES AND PENALTIES

46. Offences and Penalties

A person who contravenes these Regulations commits an offence and is liable on conviction to a fine not less than two currency points and not exceeding five currency points or imprisonment not exceeding two months or both.

**THE PARLIAMENTARY PENSIONS (AMENDMENT)
ACT, 2011.**

An Act to amend the Parliamentary Pensions Act to make provision for the type of pension scheme; a vesting scale stipulating the proportion of Government contribution that shall vest on the member upon retirement; a disability pension; fair representation of members on the board of trustees; a dispute resolution mechanism; and for other related matters.

DATE OF ASSENT: 28th December, 2010.

Date of Commencement: 21st February, 2011.

BE IT ENACTED by Parliament as follows:

1. Amendment of Section 2 of the Parliamentary Pensions Act, 2007.

Section 2 of the Parliamentary Pensions Act, 2007 in this Act referred to as “the principal Act” is amended by—

- (a) inserting immediately before the interpretation of the word “Board” the following—

“actuary” means an actuary qualified as such and appointed by the Board;

“AGM” means the Annual General Meeting of the members of the scheme including a former member receiving a pension under the scheme or with deferred benefits in the scheme;

“beneficiary or nominee” means a person designated by a member to benefit under the scheme.”

- (b) inserting immediately after the interpretation of the word “Board” the following—

“custodian” means an institution appointed by the Board for the purposes of holding safe custody of the funds, securities, financial instruments and documents of title of the scheme in accordance with such terms and conditions of service as may be specified in the instrument of appointment;

“dependant” means a son or daughter under the age of 18 years, or a son or daughter above the age of 18 years or any other person who is wholly or substantially dependent on the member;

“defined benefits scheme” means a retirement benefits scheme in which a sponsor undertakes to provide benefits expressed in the form of annuity or lump sum calculation based on work history and guaranteed return on contribution account regardless of the investment performance of the fund associated with the scheme and accordingly constitutes a contingent liability for the sponsor;

“disability” means a substantial functional limitation of daily life activities caused by physical, mental or sensory impairment and environment barriers resulting in limited participation;

“fund manager” means a person appointed by the trustees to advice on the investment of the assets of the scheme in accordance with such terms and conditions of service as may be specified in the instrument of appointment;

“hybrid cash balance scheme” means a defined benefits scheme which includes elements of money purchase pension design scheme.”

- (c) substituting for the interpretation of the word “member” the following—

“member” means a Member of Parliament and a member of staff of the Parliamentary Commission on permanent and pensionable terms contributing to the Fund;

“money purchase pension design scheme” means a scheme that provides benefits based upon the amount of money that is in a member account when benefits are due to be paid.”

- (d) inserting immediately after the interpretation of the word “pensionable emolument” the following—

“reserve account” means a reserve account established under section 20B.”

- (e) inserting immediately after the interpretation of the word “scheme” the following—

“scheme credit” means the total contributions by and in respect of a member and interest accruing on it;

“spouse” means a husband or wife by a lawful marriage.”

2. Amendment of section 4 of the principal Act.

Section 4 of the principal Act is amended by substituting for subsection (2) the following—

“(2) The scheme shall be a hybrid cash balance scheme under which members and the Government shall make contributions to the Fund in accordance with section 6.”

3. Amendment of section 5 of the principal Act.

Section 5 of the principal Act is amended by substituting for it the following—

“5. Membership of the scheme.

(1) Membership of the scheme shall consist of Members of Parliament, whether elected or *ex-officio*, and members of staff, on permanent and pensionable terms, of the Parliamentary Commission except that any member who is also a Vice President or a Prime Minister or becomes Speaker or Deputy Speaker shall not be a member of the scheme.

(2) A member who is subsequently appointed as Vice President or Prime Minister or elected Speaker or Deputy Speaker shall withdraw from the scheme and his or her benefits may be deferred under section 12A.

(3) All Members of the 7th Parliament and staff of the Parliamentary Commission shall, on the date of commencement of this Act, be deemed to have joined the scheme.

(4) For the purposes of this Act, a person who ceases to be a member in consequence of the dissolution of Parliament, or in consequence of a court order relating to any election petition, shall be deemed to continue to be a member until such time as he or she fails to be re-elected to Parliament.

(5) The benefits of the Speaker and Deputy Speaker shall be provided for under Part IVA of this Act.”

4. Amendment of section 6 of the principal Act.

Section 6 of the principal Act is amended by substituting for subsection (5) the following—

“(5) The board shall maintain a member account for each member to which all contributions made by and in respect of each member under this Act shall be credited, and from which there shall be paid individual benefits in respect of each member.”

5. Amendment of section 7 of the principal Act.

Section 7 of the principal Act is amended by—

- (a) renumbering section 7 as section 7(1); and
- (b) inserting immediately after subsection (1) the following—

“(2) Subsection (1) shall not apply to an order of court for the payment of periodical sums of money towards the maintenance of the spouse or former spouse or child, of the member to whom the pension, gratuity or other benefit has been granted.”

6. Insertion of a new section 7A of the principal Act.

The principal Act is amended by inserting immediately after section 7 the following—

“7A. Pension not subject to attachment on bankruptcy.

Where a person in receipt of a pension under this Act is adjudicated insolvent by a competent court, the person shall continue to receive the pension and the pension shall not be subject to attachment under the insolvency laws.”

“7B Restriction on use of scheme funds.

(1) The funds of the scheme shall not—

- (a) be used for speculative investment;
- (b) be lent to any person, except through securities sold on the open market; or
- (c) be invested with a bank, non-banking financial institution, insurance company, building society or other institution with a view to securing loans or mortgages, at a preferential rate of interest or for other consideration to the trustee, custodian, administrator or fund manager of the retirement benefits scheme.

(2) Notwithstanding section 7 and section 7B (1), a prescribed proportion of the benefits accruing to a member under this scheme may be assigned and used by the member to secure a mortgage or a loan for purchasing a residential house from any institution and on such terms as may be prescribed in the regulations made under this Act.”

7. Amendment of section 9 of the principal Act.

Section 9 of the principal Act is amended—

- (a) in paragraph (a) by inserting immediately after the word “contributions” the words “ by and in respect” ;
- (b) in paragraph (c) by deleting the word “members” and inserting immediately after the word “contributions” the words “by and in respect of members.”

8. Amendment of section 10 of the principal Act.

Section 10 of the principal Act is amended by inserting immediately after subsection (3) the following—

“(4) The contributions by and in respect of each member under section 6 shall be paid to the Fund before the fifteenth day of the next following calendar month.”

9. Insertion of a new section 10A of the principal Act.

The principal Act is amended by inserting immediately after section 10 the following—

“10A. Payments from the Fund.

The following payments shall be made from the Fund—

- (a) pension;
- (b) refund of contributions; and
- (c) expenses incurred in the management and administration of the Scheme.”

10. Amendment of section 11 of the principal Act.

Section 11 of the principal Act is amended in subsection (2) by substituting for the words “Speaker of Parliament” the words “Parliamentary Commission.”

11. Amendment of section 12 of the principal Act.

For section 12 of the principal Act there is substituted the following—

“12. Pension for former members.

(1) Pension shall be paid to a member who retires or ceases to be a member on or after attaining forty-five years of age, subject to service as a member for a continuous period of five years or more.

(2) The pension payable to a former member shall be calculated basing on a formula provided in Schedule 1 to this Act.

(3) The board may by Statutory Instrument in consultation with the Parliamentary commission amend the schedule after an actuarial review

(4) The pension payable to a former member on his or her retirement shall be of such amount as can be purchased by his or her scheme credit at the date of retirement by monthly payments.

(5) Notwithstanding subsection (4), a member entitled to a pension shall have an option of receiving a commuted lump sum payment of not more than twenty five percent of his or her Scheme credit.”

12. Insertion of new section 12A of the principal Act.

The principal Act is amended by inserting immediately after section 12 the following—

“12A. Retirement as a consequence of another Government appointment.

The benefits of a member, who retires or ceases to be a member as a consequence of another Government appointment with a retirement scheme, shall be deferred until the member retires or ceases to hold the new appointment.”

13. Replacement of section 13 of the principal Act.

For section 13 of the principal Act, there is substituted the following—

“13. Refund of contributions.

(1) Subject to section 12A, a member who retires or ceases to be a member whose age is less than forty-five years, or who has had less than five years of pensionable service, shall be entitled to a refund of his or her scheme credit.

(2) For the purposes of subsection(1), the proportion of Government contribution that vests in the member shall be calculated as follows—

- (a) ten percent of contribution shall vest after service of less than or equal to one year;
- (b) twenty percent of contribution shall vest after service of one year but less than two years;
- (c) forty percent of contribution shall vest after service of at least two years but less than three years;
- (d) sixty percent of contribution shall vest after service of at least three years but less than four years;
- (e) eighty percent of contribution shall vest after service of at least four years but less than five years;
- (f) one hundred percent of contribution shall vest after service of at least five years.

(3) This section shall not apply to a person who was a member before 2010.”

14. Amendment of section 14 of the principal Act.

Section 14 of the principal Act is amended by substituting for subsection (2) the following—

“(2) Subject to section 12(5), a member whose payment is deferred under subsection (1) shall, on attaining the age of forty-five years or more, be paid his or her scheme credit as a pension.”

15. Amendment of section 15 of the principal Act.

Section 15 of the principal Act is amended by inserting at the end of the section the words, “as may be determined by the Board.”

16. Insertion of a new section 15A of the principal Act.

The principal Act is amended by inserting immediately after section 15 the following—

“15A Disability pension

(1) The board may, in addition to payments made under this Act, grant a disability pension where a member is required to retire as a result of—

- (a) sustaining an injury in the course and arising out of performing his or her official duties or due to a travel accident; or
- (b) contracting a disease to which he or she is exposed by the nature of his or her duties.

(2) For the purpose of subsection (1), injury or disease means injury or disease which is not due to, aggravated or contributed by negligence or misconduct on the part of the member.”

17. Replacement of section 16 of the principal Act.

The principal Act is amended by substituting for section 16 the following—

“16. Death of a member.

Where a member dies while in pensionable service, his or her spouse or dependant, and where applicable a person nominated by the member before the member's death shall be paid a refund of his or her scheme credit.”

18. Insertion of a new section 16A of the principal Act.

The principal Act is amended by inserting immediately after section 16 the following new section—

“16A. Death of a person receiving pension.

Where a person dies when he or she is receiving a pension under this Act, his or her spouse, dependant or where applicable a person nominated by the member before the member's death shall be entitled to receive the deceased member's pension.”

19. Amendment of section 17 of the principal Act.

Section 17 of the principal Act is amended by substituting for subsection (1) the following—

“(1) Where a person receiving a pension under this Act is elected as a member of Parliament or appointed as a member of staff of the Parliamentary Commission on permanent and pensionable terms contributing to the Fund, the payment of the pension or any part of it shall be suspended during the period he or she is a serving member.”

20. Replacement of section 18 of the principal Act.

The principal Act is amended by substituting for section 18 the following—

“18. Establishment of board of trustees.

(1) There is established a Parliamentary Pension Scheme Board of Trustees consisting of—

- (a) the Minister responsible for finance or his or her representative;
- (b) two back bench Members of Parliament elected from different political parties or organisations one of whom shall be a woman;

- (c) one elected backbench commissioner;
- (d) one member of staff elected by the members of staff of the Parliamentary Commission; and
- (e) two pensioners elected by the pensioners, one of whom is a former staff of the Parliamentary Commission and the other a former Member of Parliament.

(2) The chairperson of the board shall be elected by the board of trustees from the two back bench Members of Parliament from different political parties or organisations and pensioners.

(3) In the absence of the chairperson, the members present shall elect from amongst themselves, a chairperson for the purposes of the sitting.

(4) The Clerk to Parliament shall be the secretary to the board and chief executive of the fund.

(5) The board shall be responsible for the management and control of the scheme.

(6) The board shall appoint an actuary, custodian, fund manager, auditor and any other professional of the Scheme as the board may deem necessary for the proper administration of the Fund.

(7) A member of the board of trustees shall serve for a period of five years but may be eligible to serve one other term.

(8) A person shall cease to be a trustee if he or she—

- (a) is sentenced to imprisonment by a court of competent jurisdiction for a period of six months or more;
- (b) becomes insolvent or makes an arrangement or composition with his or her creditors generally;
- (c) becomes a person of unsound mind;

- (d) fails without reasonable cause and without the consent of the other trustees to attend four consecutive meetings of the board and the board resolves in a meeting that by reason of such failure he or she shall cease to be a trustee;
- (e) removed by a resolution of members in an AGM;
- (f) in the case of a trustee appointed by virtue of the office he or she holds, on ceasing to hold that office;
- (g) resigns;
- (h) is forbidden to act as trustee under any written law; or
- (i) dies.”

21. Insertion of new sections 20A, 20B, 20C, 20D, 20E and 20F.

The principal Act is amended by inserting immediately after section 20 the following new sections—

“20A. Interest on member accounts.

(1) Interest on the scheme credit of each member shall be calculated at the rate specified in Schedule 2.

(2) Subject to section 24, the board may, in consultation with the Parliamentary Commission and after actuarial recommendation, by statutory instrument, amend Schedule 2.

20B. Reserve Account.

There shall be established a reserve account of the fund to which shall be deposited any—

- (a) penalties required by this Act to be paid into the fund;
- (b) special contribution and any contribution which cannot be allocated to the account of any member of the fund;

- (c) income from investments such as the board may determine; and
- (d) any other income authorised by this Act.

20C. Accounts and audit.

(1) The board shall cause to be provided and kept proper books of account and records with respect to—

- (a) the receipt and expenditure of monies by, and other financial transactions of the fund;
- (b) the assets and liabilities of the fund, and shall cause to be made out for every financial year a balance sheet and a statement showing details of the income and expenditure of the fund and all its assets and liabilities.

(2) Not later than three months after the close of every financial year the accounts, including the balance sheet of the fund relating to that financial year, shall be audited by the Auditor General or an auditor appointed by him or her.

(3) As soon as the accounts of the fund have been audited, and in any case not later than six months after the audit, the board shall submit to the AGM a copy of the audited statement of accounts together with a copy of the audited report on the statement of accounts made by the auditors.

20D. Investment.

(1) The Scheme shall have an investment policy approved by the board.

(2) All monies in the fund, including the reserve account, which are not for the time being required to be applied for the purpose of the fund, shall be invested in such assets as may be determined by the Board.

20E. Exemption from stamp duty.

No stamp duty shall be chargeable under the Stamps Act in respect of any instrument executed by any person on behalf of or in favour of the fund or in respect of the payment of any benefit or the refunding of any contribution under this Act in any case where, but for this exemption, the fund or any person acting on behalf of the fund would be liable to that duty.

20F. Exemption from income tax.

A pension, benefit or refund paid under this Act shall be exempt from income tax.”

22. Amendment of section 23 of the principal Act.

Section 23 of the principal Act is amended—

- (a) in subsection (1), by substituting for the word “parliamentary commission”, the word “board”;
- (b) in subsection (2), by—
 - (i) substituting for the word “parliament” the word “AGM”; and
 - (ii) substituting for the words appearing after the word “months” the words “from the date of submission to the board.”

23. Insertion of a new section 23A of the principal Act.

The principal Act is amended by inserting immediately after section 23 the following—

“23A. Dispute resolution.

(1) Where the board decides in respect of any member—

- (a) that a pension or other benefit may not be granted under this Act; or

- (b) that a pension or other benefit which may be or has been granted under this Act shall be withheld, reduced in amount or suspended,

the member or, if he or she is dead, his or her spouse, dependant, beneficiary or nominee may, within ninety days of being informed of the decision, apply in writing to the board for the case to be referred to an arbitrator in accordance the Arbitration and Conciliation Act”.

24. Amendment of section 24 of the principal Act.

The principal Act is amended by substituting for section 24 the following—

“24. Regulations.

(1) The board in consultation with the Parliamentary Commission may, by statutory instrument, make regulations for the effective implementation of this Act.

(2) The board in consultation with the Parliamentary Commission may, by statutory instrument amend schedules 1 and 2 to this Act.

(3) A statutory instrument made under this section shall be laid before Parliament and Parliament shall pronounce itself on the statutory instrument by way of a Resolution within twenty one days from the date on which it is so laid.”

25. Amendment of section 25 of the principal Act.

Section 25 of the principal Act is amended by substituting for the word “Parliament” wherever it appears, the word “AGM”.

26. Insertion of new schedules 1 and 2 to the principal Act.

The principal Act is amended at the end by inserting the following new schedules—

“Schedule 1.

A hybrid cash balance benefit formula;

$$(a) \text{ Pension} = \frac{\text{AF}}{\text{CAF}} \times \text{Fr}$$

**THE PARLIAMENTARY PENSIONS (AMENDMENT) (NO. 2)
ACT, 2011**

An Act to amend the Parliamentary Pensions Act, 2007 to specify the benefits for a person who ceases to hold the office of Speaker or Deputy Speaker and for related matters.

DATE OF ASSENT: 28th December, 2010.

Date of Commencement: 21st February, 2011.

BE IT ENACTED by Parliament as follows:

1. Amendment of Act 6 of 2007.

The Parliamentary Pensions Act, 2007, in this Act referred to as the principal Act, is amended by inserting immediately after Part IV, the following new Part—

“PART IVA—RETIREMENT BENEFITS FOR A SPEAKER OR DEPUTY
SPEAKER

20G. Interpretation for Part IVA.

In this Part, unless the context otherwise requires—

“currency point” has the value assigned to it in schedule 3 to this Act;

“retirement” means ceasing to hold office as Speaker or Deputy Speaker other than under the circumstances specified under section 20H (3) (a) (b) and (c).

20H. Benefits for a Speaker or Deputy Speaker ceasing to hold office.

(1) A person who ceases to hold the office of Speaker is entitled to the benefits specified in Schedule 4.

(2) A person who ceases to hold the office of Deputy Speaker is entitled to the benefits specified in Schedule 5.

(3) A person is not entitled to receive a benefit under subsection (1) or (2) if that person is removed from the office of Speaker or Deputy Speaker for—

- (a) abuse of office;
- (b) misconduct or misbehaviour; or
- (c) being disqualified from being a member of Parliament.

(4) Where a person ceases to hold the office of Speaker or Deputy Speaker on the ground of infirmity of body or mind, that person shall receive the benefits similar to those provided for a person who ceases to hold the office of Speaker or Deputy Speaker, upon retirement.

(5) A person who resigns or ceases to be Speaker or Deputy Speaker under subsection (3)(a) and (b) but remains a member of Parliament, is entitled to rejoin the scheme provided Government does not make a contribution and section 6 shall apply to him or her.

(6) The funds for the administration and management of the benefits under subsection (1), (2) and (4) shall be paid directly from the consolidated fund.

(7) The benefits provided for under this Part shall be administered and managed by the Parliamentary Commission.

(8) For the avoidance of doubt, the retirement benefits of the Speaker and Deputy Speaker under this Part, shall not form part of the Parliamentary Pensions Scheme Structure.

20I. Funeral of a Speaker or Deputy Speaker.

The funeral of a person who dies while holding the office of Speaker or Deputy Speaker shall be conducted in accordance with Part D of Schedule 4.

20J. Benefits of a spouse of Speaker or Deputy Speaker who dies in office.

(1) A spouse or spouses of a person who dies while holding the office of Speaker shall be granted the benefits specified in Part C of Schedule 4.

(2) A spouse or spouses of a person who dies while holding the office of Deputy Speaker shall be granted the benefits specified in Part C of Schedule 5.

(3) For the avoidance of doubt, the benefits of a spouse or spouses of a person who dies while holding the office of Speaker or Deputy Speaker shall be granted to the spouse or spouses collectively, until their death.

20K. Disapplication of scheme to Speaker and Deputy Speaker.

(1) Where a person who ceases to hold the office of Speaker or Deputy Speaker is entitled to the benefits under this Part, that person is entitled to a refund of the contributions with interest made by the person to the Scheme.

(2) For the avoidance of doubt, a person referred to in subsection (1) is entitled to a refund of the monthly contributions made by that person, and the contributions made by Government in respect of that person, together with interest up to the time of becoming Speaker or Deputy Speaker.

(3) Where a member becomes Speaker or Deputy Speaker, that member or Government is not required, during the period that the member is Speaker or Deputy Speaker, to contribute to the scheme.”

2. Insertion of new section 23B.

The principal Act is amended by inserting immediately after section 23A the following—

“23B. Amendment of Schedules.

(1) The allowances and benefits granted under Part IVA, shall be reviewed every five years.

(2) The Minister responsible for finance shall amend schedule 3.

(3) Parliament may, by resolution, amend schedule 4 and 5.

(4) Notwithstanding subsection (1), a person who is Speaker or Deputy Speaker may leave his or her contribution in the scheme as deferred benefits until he or she ceases to be Speaker or Deputy Speaker.

(5) A person who opts to defer his or her benefits under subsection (3) shall on ceasing to be Speaker or Deputy Speaker be entitled to his or her benefits.”

3. Transitional provisions relating to the current Speaker and Deputy Speaker.

(1) A person who is Speaker or Deputy Speaker at the commencement of this Act shall cease to contribute to the scheme for the period that the person remains Speaker or Deputy Speaker.

(2) During the period that the person referred to in subsection (1) remains Speaker or Deputy Speaker, Government shall not contribute to the scheme in respect of that person.

4. Insertion of new Schedules 3, 4 and 5.

The principal Act is amended by inserting immediately after Schedule 2, the following new Schedules—

“SCHEDULE 3

Section 20G

A currency point is equivalent to twenty thousand shillings.”

SCHEDULE 4

RETIREMENT BENEFITS FOR A SPEAKER OR DEPUTY SPEAKER

Part A

Benefits of a Speaker ceasing to hold office by retirement

1. A monthly allowance equivalent to sixty percent of the monthly salary of the sitting Speaker of Parliament.
2. One four-wheel chauffer driven car with a cubic capacity of 3500 to 4000.
3. Two security guards.
4. Two domestic staff.
5. Medical care for the retired Speaker and the spouse or spouses
6. An allowance equivalent to thirty three currency points per month for utilities.

Part B

Benefits of a Speaker who ceases to hold office by resignation

1. A monthly allowance equivalent to sixty percent of the monthly salary of the sitting Speaker of Parliament.
2. One four-wheel chauffer driven car with a cubic capacity of 3500 to 4000.
3. Two security guards.
4. Two domestic staff.
5. Medical care for the Speaker and the spouse or spouses.

Part C

Benefits of a spouse or spouses of a Speaker who ceases to hold office upon death

1. A monthly allowance equivalent to sixty percent of the monthly allowance payable to the deceased speaker.
2. One four-wheel chauffer driven car with a cubic capacity of 3500 to 4000
3. Two security guards.
4. Two domestic staff.
5. A health insurance policy of up to fourteen currency points per month.

Part D

Funeral arrangements for a Speaker or Deputy Speaker who dies while in office

1. A person who dies while holding the office of Speaker or Deputy Speaker shall be accorded a state funeral.
2. Thirty percent of the gross annual salary of the Speaker or Deputy Speaker shall be used towards the funeral expenses.
3. An official statement about the death of the Speaker or Deputy Speaker shall be made on television, radio, print media and other electronic media.
4. Government shall declare a mourning period.
5. Martial music shall be played on national radio during the mourning period.
6. National flags shall be flown at half mast during the mourning period.
7. The casket shall be draped in the national flag.
8. The casket cortege shall be escorted by the Uganda Police Force in top-roof flash light vehicles.
9. The casket shall be carried by ceremonially uniformed pall bearers

from the Uganda Police Force.

10. The body shall lie in state for one day, for public viewing.
11. A condolence book shall be opened for signing by political leaders, dignitaries and the public.
12. An official guard shall keep vigil and a bright light shall light the casket throughout the night.
13. Parliament shall pay tribute to the Speaker or Deputy Speaker with a band in attendance playing dirges.
14. A funeral service shall be held in honour of the late Speaker or Deputy Speaker in a place of worship or in a place designated by Cabinet.
15. The casket shall be transported to the burial place by a hearse.
16. A public holiday shall be declared on the day of burial, in accordance with the Public Holidays Act.
17. At the burial, there shall be a seventeen gun salute.

SCHEDULE 5

Part A

Benefits of a Deputy Speaker ceasing to hold office by retirement

1. A monthly allowance equivalent to sixty percent of the monthly salary of the sitting Deputy Speaker.
2. One four wheel chauffer driven car with a cubic capacity of 3500 to 4000.
3. One security guard.
4. One domestic staff.
5. Medical care for the former Deputy Speaker and the spouse or spouses.
6. An allowance equivalent to thirty three currency points per month for utilities.

Part B

Benefits for a Deputy Speaker who ceases to hold office by resignation.

1. A monthly allowance equivalent to thirty three percent of the monthly salary of the sitting Deputy Speaker.
2. One four wheel chauffeur -driven car with a cubic capacity of 3000 to 4000.
3. One security guard.
4. One domestic staff.
5. Medical care for the former Deputy Speaker and the spouse or spouses.

Part C

**Benefits for a spouse or spouses of a person who dies while holding
the office of Deputy Speaker**

1. A monthly allowance equivalent to sixty percent of the monthly allowance of the deceased Deputy Speaker.
2. One four wheel chauffeur -driven car with a cubic capacity of 3000 to 4000.
3. One domestic staff.
4. Medical care for the spouse or spouses.”
